Parish Council Chairman's message

Welcome to the latest edition of your Parish Newsletter. The way things are at the moment, we are in for a very busy 12 months with many large planning applications on the horizon, the new allotments site having complications and subject to the weather, a very fast-growing environment. Much of this will define the future of this area so it's important to get things right, in order to reap the benefits later.

The by-pass (A4440) is witnessing an unprecedented amount of large planning applications. The field south of Warndon Woods has an application for some very large warehouses which is not in accordance the local plan (SWDP), Gtech is coming back with a larger building application and now rumours are on us that suggest the Worcester City Football Club wants to come and play in a field north of Warndon Woods! This will inevitably have a serious long-lasting effect on the bypass and through traffic in the Villages. It's critical that we get the correct results and lock in our future using the new Neighbourhood Plan initiative.

Many of you will have been impacted by the greenery around your homes not being maintained by the City Council, in a lot of cases this is because the original developers of your property retained ownership of small plots of land throughout the Villages. Plans are underway to get all this sorted out, but it will take time because no-one involved gains anything, but must fund legal fees to transfer the land ownership. We realise that this is frustrating and annoying to many of you, but please understand that there is very little that your Parish Council can do to help.

There is good news on road safety and speeds through our feeder roads. The number of vehicles doing over 35mph is down from an average of 25% of the motorists, to a new average of 6 -7%. We are very pleased with this and want to thank the police and other agencies, for their cooperation in this matter.

We still have the odd few people that do 65-70mph in the 30mph speed limit

Allotments update

The status of the allotments and the new allotments site has caused a lot of activity over the last few months. In an effort to keep all residents informed the following is an update, as of this month.

All the current allotments are fully occupied by residents from the Warndon Parish, no-one is allowed an allotment, on the Mabs Orchard site, that lives outside the Parish boundary. Any vacancies that occur will be dealt with by allocating a space to someone from our long waiting list, which currently has 24 people on it.

The current allotments extension is delayed, possibly until March 2018. There are a number of reasons for this but it's mostly due to the discovery that we need to complete an archaeological survey on the site before commencement, this is likely to be in Sept/Oct 2017 and people will be invited to get involved.

The City Council has now put forward it's proposals for the remainder of the site at a public meeting and is now considering the feedback they received.

All current waiting list persons will not need to do this, as we will already circulate updates to them.

As a busy summer for the Wardens comes to an end, it is with a smile that I recall some of the wonderful projects that we have been involved with. These include working with volunteers, Councillors, Police Officers and residents, to resolve issues and deliver practical enhancements throughout the Villages. My personal highlight is being able to work with volunteers; enabling and assisting the continued development of active groups. Volunteering is now almost

synonymous with life in Warndon Villages - this wonderful leafy green landscape is a joyous place, but it does require a lot of work. One cannot under estimate the importance of volunteers in maintaining and enhancing the environment around us.

Whilst we are on the subject of volunteers; a colossal thank you to everyone that has volunteered in Warndon Villages since the last Newsletter! Friends of Warndon Villages volunteers (FoWV) have revisited Tattershall and Trevithick parks to carry out shrub and footpath management. The group have also helped with accessibility around Lyppard and Corfe Avenue ponds.

Earlier in the year volunteers worked to extensively renovate the footpath to alleviate a flooding issue at **New Plantation Wood.** This project was only made possible, through funding from County Cllr. Roberts divisional fund, which provided the surfacing materials; thank you!

The highlight of the summer volunteer season has been the FoWV picnic in **Sudeley Park** in July. Seventeen volunteers joined forces to completely revamp the seating areas within the park, including hand weeding and resurfacing with gravel. The results look stunning.

Worcester City Council -Tree Policy (cont'd)

If you are reporting a dangerous tree, you will need to provide evidence why you believe it is a public danger.

Common concerns;

A tree swaying in the wind does not in itself make it a dangerous tree, trees will naturally sway in the wind, the pliability in the branches is a natural mechanism that helps prevent fracture.

A tree that has grown with a lean does not in itself make it dangerous; a tree will develop fatter growth rings on one side to make it more stable. There may be a problem if a previously upright tree suddenly develops a lean.

If you are still concerned that a tree on a private property/land or if you believe that a Tree on council land or a highway is dangerous or is a public danger then please contact the **Tree Protection Officer** at the **City Council** at **planning@worcester.gov.uk**. If the tree is imminently dangerous the council may undertake a site visit to confirm if any action can be taken under the Miscellaneous Provisions Act 1976.

Falling leaves/fruit/flowers/seasonal debris

Although they can cause a lot of inconvenience, falling leaves and debris are not regarded as a 'nuisance' in the legal sense and a tree owner has no obligation to clear them. It is usually up to the tree owner or the neighbours affected to clean up or undertake their own maintenance in the case of gutters blocked by leaves.

Tree roots/ subsidence/ damage to property

If a tree is found to be causing damage to a neighbour's property it may be classed as a legal nuisance and the tree owner may be liable for any costs or damage caused. If you believe that a neighbour's tree is causing damage or subsidence to your property you must inform your neighbour and your building insurance company as soon as possible. Insurance companies will usually deal with subsidence issues on your behalf. Technical reports demonstrating the tree is the cause of the damage are normally required.

Worcester City Council -Tree Policy

As our green environment is maturing and as referred to in the Chairman's message, regarding ongoing issues over land ownership, we felt it might be useful to share Worcester City Council's Tree Policy, full details of which can be viewed online https://www.worcester.gov.uk/trees

Overhanging branches/Loss of light/ Dangerous trees

Under English common law there is a general right to cut overhanging branches back to your property boundary (The owner of the tree is not obliged to cut them back, although they may do so) If you or they intend to cut overhanging branches you must not go beyond your boundary or top their trees without their permission.

It is advisable to agree any work with your neighbours beforehand and offer back any arising's from the tree, although they are not obliged to accept them and therefore you will need to make arrangements for their disposals. It is always advisable to check with the City Council if the tree is protected by the **Tree Preservation Order** (TPO) or in a **conservation area** as you will need to apply to the council with the owners consent to do the work.

Loss of Light or Satellite/TV Reception

There is no absolute right to light, a view, or satellite signal, therefore if trees are an obstruction you will need to talk to your neighbour or the land owner regarding the management of their trees.

It may be possible for the council to intervene in extreme cases in the form of a high hedge complaint under the anti-social behaviour act.

Dangerous Trees

Every tree owner has a general duty of care to ensure their trees do not pose an unacceptable risk to other people on or adjacent to their land. You will however only be liable for injury or damage caused by trees if you are found to be negligent in some way e.g. by not taking reasonable care to regularly inspect or undertake essential work to your trees.

Parish Finance

Council Tax Bills are confusing and our 5.6% increase for this year needs to be put in perspective. For a Band D property in the Warndon Parish area this represents a £1.34 per year increase or less than £0.03 per week increase in our precept. Overall our precept is just 1.6% of your overall Council Tax Bill. The table shows the impact for other Bands.

The Parish spends approximately £100,000.00 per year and this is all funded by our Precept which is collected as part of your Council Tax Bill, we have no other substantial income. The money is spent in several different areas such as Environmental Maintenance (Major funding of our local Environmental Warden, Enhanced Grass Cutting, Tree and Shrub Maintenance and the cost of dog bins), Community Services (Lyppard Hub support, allotments, play areas and the annual Parish Fete). In addition, this year we will commence the development of a Neighbourhood Plan and be positioning Three Community Defibrillators across the parish to help safeguard our local residents. We also have some small administration charges.

Planning procedure cont'd

Insufficient parking - particularly relevant to larger developments; lack of public transport (i.e not situated on an existing bus route) may cause 'nuisance' parking in your immediate area or on other roads in the wider area. (i.e similarly to the situation residents in other areas of the Villages have experienced, close to Worcester Royal Hospital / Kings Court)

Traffic concerns - impact on the immediate road network and for larger developments, the wider effects up to the motorway Junctions 6 &/or 7 - M5.

Noise nuisance - close to residential area (Change of use for a site may give rise to additional noise levels which may be inappropriate with a residential area) i.e B8 usage; it is not uncommon for such activities to operate on a 24 hours basis.

Traffic noise nuisance - (ie increased traffic volumes, type of business usage shift change times, HGV vehicle deliveries and despatch particularly if business is in 24 hr operation)

Light pollution - particularly associated with B8 business usage as opposed to B1 offices. Generally brighter lighting and required to remain on a 24/7 basis.

Increased traffic - impact on residential streets.

Ecological - Green spaces/wildlife habitat - additional noise/ light pollution generated by 24 hour operation, may have an adverse effect on wildlife in the area.

Conservation areas - consider if the proposed development have a detrimental impact on a Conservation area in the Parish (Warndon Court and Trotshill Conservation areas) - more details of these can be found on the Worcester City Council website.

Archeological interest – impact on ancient remains.



Planning Procedure

If you wish to make a comment on a Planning Application, whether it is a neighbour's extension to their home, or a large development of land, there is a formal process in which to do this. Should you not be familiar with this process we have provided some guidance on how you can do this.

Your comment can be either *in favour* or *against* a Planning application. If you wish to object to the application, to carry weight, your comments should be constructive and relevant to Planning matters.

Please follow the instructions below;

Go to: Worcester City Council website: http://planning.worcester.gov.uk/ OcellaWeb/planningSearch

Search for the Planning Application by Planning Reference No (if known) or by address in the appropriate box provided.

- Click on the reference (in blue font) to show the full details of the application
- Click on the box marked 'Enter Comment'
- You will then be presented with a box to complete with your personal details and add your comments.
- Click on 'View Documents' to see other Consultation responses, documents, drawings and plans.

Alternatively you may express your views by writing to the Planning Department.

For general guidance, when making an objection the key points to consider are listed below;

Change of use of the land/property- the South Worcestershire Development Plan, adopted in early 2016, sets out land allocated for development and the type of development i.e **B1** Business (Offices), **B2** or **B8** storage or distribution.

Your Parish Council does a lot to maintain the green environment we live in to a high standard and is probably not recognised by many people for what we do on behalf of the local community, mostly we suspect because it's unclear what the split of responsibilities of the County/City/Parish Councils are.

Defibrillators in Warndon Villages

Warndon Parish Council has considered installing publicly accessible defibrillators in the Parish for several years. Recently we found a charity scheme, which will enable us to fit three defibrillators in key areas of the Villages. The charity offering match



funding is **Hereford & Worcester First Responder Charity**, sponsored by local charity **Four Acre Trust** and supported by **West Midlands Ambulance Service**, to deploy defibrillators in rural areas. They also offer ongoing support and training in the community for zero cost. The total cost to the Parish Council to install all three defibrillators, is expected to be around £2000.00.

The three defibrillators are now in the process of being installed. Their locations have been planned so each is within a fairly easy distance to get to, depending on where an incident occurs and they are sited in familiar places as follows:

<u>Lyppard Hub</u>- We are grateful to **Worcester City Council**, **Place Partnership** and the **Trustees of Lyppard Hub** who have given permission for us to mount one unit on the outside of **Lyppard Hub**. The unit is located by the main entrance to Lyppard Hub, on the left hand side wall, as you face the front door.

<u>Tesco Express - Tesco</u> has kindly given permission to put a defibrillator on the outside of their building. The unit will be located on the front outside of the building. We are grateful to the Manager of **Tesco Express**, **Frankie Tsang** of **Lyppard Grange Properties Ltd** and **Fisher German** for their help in completing this project at no cost to our residents.

<u>Dugdale Drive or similar location in the South of the Parish.</u>

We had hoped to mount the third unit on a lamp-post in Dugdale Drive but this has proved to be impossible. We continue to search for a suitable position for our third unit. <u>If anyone can help</u> please let us know, by emailing <u>defibrillators@warndonparishcouncil.org</u>.

Defribrillators (Cont'd)

Our requirements are simple, a prominent, easily accessible site with a mains supply that will rarely be used.



The units will be mounted in bright yellow boxes which contain a defibrillator and a heater, in case the temperature drops below -4 Deg. C and will be accessible by a coded keypad. The defibrillators are semi-automatic and designed, so that no experience is necessary to use them. The machine, once opened and switched on, will talk you through every operation and will only administer a shock to the patient if it is necessary. It even safeguards you from making any errors, because even if you push the shock button by mistake, the patient will only be shocked if the machine shows it to be necessary. Some CPR awareness would also be useful.

The Parish Council, in conjunction with West Midlands Ambulance Services, will be arranging training sessions after the school holidays. We intend to hold these Defibrillator Awareness sessions at Lyppard Hub on Sunday 1st October 2017. These will be held to allow as many people as possible to attend, realistically we can probably handle audiences up to 50 people per session, so places may be limited. Ideally, we would like to get a good mix of people, geographically located throughout the Parish, familiar with these machines and their ability to save lives.
