The information you give cannot be treated as confidential and may be shown to any person who asks to see it.

If the County Council proceeds with this claim, there may be a Public Inquiry, which would be held locally, e.g. in a Village Hall. Your evidence will be more valuable if you are prepared to attend an Inquiry and give evidence in person. The County Council will help you to give your evidence.
