4. Police Officers Report

PC Hall said that the issues raised on the returned survey forms will be evaluated at the next Pact meeting.

At the moment there has been no cost for the "Youth Bus" but it is expected to be in the region of £100.00 per session.

There has been no feedback as yet as to the change of speed limits in Norton but PC Hall said he will try and set up some speed surveys at various times and sites.

DC Clive Holt stated that he had received a complaint re "why the parish does not have speed cameras", however this complaint had not been received by the PC. The local PC Simon Hall said he would speak to Mike Digger to try and arrange for him to attend a PC meeting to discuss VAS signs. DC Clive Holt also stated that speed humps would not be an option.

5. District Councillors Report

DC Clive Holt stated the repair of a pavement in Lenchwick has now been carried out, he also has informed Roy Fullee at WCC of the urgent need for the repairs to Kings Lane, also kerbing and road surfaces are in urgent need of repair.

DC Holt told the PC the WDC had achieved an "Investors in People" award and that 4 Councils in the County had achieved Excellence awards.

DC Clive Holt then informed the meeting that he would not be standing for re-election at the forthcoming elections in May but hinted that Mr. C. Homer may stand.
