6. Chairman's Report

The Chairman and R. Houghton (prospective Councillor attended the SWDP meeting to gain an insight and any information available.

An email was sent to PC Simon Hall regarding the Neighbour Watch who responded by saying it is WIP.

The preferred Options Consultation for Planning took place on the 25th October. As Norton is a class 4 Village we have not been targeted nor are we mentioned on any current planning strategy maps.

It was still a concern as landowners had come forward to identify their land as available.

The known sites were discussed and as many Councillors that could would attend the consultation.

10. Finance & Policy Committee Report

The accounts were reviewed and our expenditure vs. budget over the first 6 months were on par and we will stay within our precept. The extraordinary expenditure we are required / proposing to make during the next financial year will see no rise in the precept.

Projects for the next 12c months are as follows,

- 1. Street Lighting upgrade to enable certification (estimated at £12,000)
- 2. Two extra dog bins including the first year emptying, £1,000
- 3. Vehicle Activated Signage contribution, £400
- 4. Signs for Playing Field (Dogs on Lead), £200

"Street Lighting will be funded from existing surplus funds"

11. Community & Outreach Committee Report

A street Lighting inspection has been requested to determine the overall condition of our lights. The lights and columns that do not pass will need to be repaired / upgraded. N & L has two redundant lights that need to be removed, and two lights installed on No's 9 & 10 that will not need to be required to be certified for another 4-5 years. Ten lights have never been certified.

Our lights should be on our asset register and they currently are not. These need to be added and also insured.

This item will be placed on the next meeting agenda.

Worcestershire is currently conducting a Broadband survey. Money has been made available to help rural Broadband in this area. Councillors agreed to send the "link" survey out to our friends and people they know in the area.

The projected budget for the VAS project in conjunction with Harvington and WCC, the requirements for siting the poles were reviewed. Maps were passed out for Lenchwick, Kings Lane and the Evesham Road for Councillors living in those areas to identify potential sites to enable the PC to submit these to WCC Highways Department. It was noted that funding towards the overall cost would be received from Evesham Market Town Partnership (£2000) and that Norton & Lenchwick will receive £700) from County Councillor C. Holt towards the project
