A note of correspondence received had been periodically sent out to Members under the "Clerk's Digest" since the last meeting. The clerk reported a newly advised WDC - standards Committee meeting on 15/9/2010.

The meeting closed at 21:35 hrs.

The Clerk sought guidance regarding purchase of signage it was agreed (MB/SM) unanimously to purchase a new 3M DFS and not to proceed with the purchase of the Westcotec sign from Hallow P.C.

#### New Matters:

Following discussion with Pc Wood regarding Newbury Coaches use of Old Road as a pick up point the clerk was instructed to write to Newbury Coaches to seek to minimise the road safety risk.

SLB reported that following closure of the Swan pending refurbishment work, frustrated customers were speeding along Old Road to turn at the hammerhead putting children playing outside their houses at risk. Confrontations between concerned residents and drivers had already occurred. It was agreed (SLB/SM) to ask Pc Wood to look into this and take appropriate action.

In the light of the dissatisfaction with the attitude displayed by the Highway Authority in the responses outlined above, the Clerk was asked to seek a meeting for Councillors with County Councillor D. Prodger who was the responsible portfolio holder. Councillor R. Adams was asked to attend.

Members were supplied with contact details of the PPW. AL was to contact him to try to establish dialogue.

## **<u>2010.103</u>** Training.

It was agreed that a further in house training session would be held on 12<sup>th</sup> October following any extra meeting of the Council or otherwise at 7:30 p.m. at the Chairman's house.

## **<u>2010.104</u>** Bulb Planting

It was agreed (MH/SM) to purchase 200 daffodil bulbs at a cost of approx £20, to be planted by S. Gwilliam. The Clerk was to make appropriate arrangements.

#### 2010.105 Local Referendums to Veto Excessive Council Tax Increases.

Members noted Central Government Proposals in this connection and were supplied with a copy of the Worcestershire CALC response.

#### 2010.106 Parish Plan.

After lengthy discussion it was agreed to pursue the development of a Whittington Parish Plan inviting public participation, the extent of which would dictate whether the development of a Plan proceeded. It was agreed that the Clerk would collate submissions to be sent to him by Councillors to produce a flyer to invite public involvement which would be essential to the process, with a view to arranging a public meeting possibly involving input from Whittington School to engage parents.

## **2010.107** District and County Councillors' Report – For Information.

County and District Councillor Adams welcomed WPC (SLB) attendance at the Pershore area Forum on 16/9/2010. He reported that budget cuts of up to 25% over the next 4 years were now being contemplated. Health services in the County would be reviewed under the terms of central Government's proposals.

He noted the concerns re glass emissions on the B4084 from lorries attending the Envirosort facility, indicating that this could also be addressed at a meeting of the liaison group in early October.

He reported changes & proposals for changes of occupation in the premises neighbouring the Envirosort facility including the Gypsum recycling operation (understood awaiting environmental approvals), a training centre, a transport depot, and a go-karting operation (planning application pending).

WDC had responded to consultation on Council Tax referendums including its opposition to proposals for these measures to be applied to Parish Councils.

# **<u>2010.108</u>** Police Report - For Information.

Pc Wood reported that there had been two (targeted) instances of criminal damage and one assault in the last two months. Pcso Ben Allchurch was expected to replace pcso Fogwill soon. He was transferring from Redditch and would work with Pc wood in a (to him) new (rural) scenario. He had undertaken two "highly visible" surveys on the B4084 recording speeds in the low 40's, he anticipated higher speeds from two planned "covert" surveys to be undertaken soon.

Questioned regarding the Newbury Coaches pick up in Whittington he advised that the Council contact Newbury Coaches to improve the situation. (See 2010.102 above)

Worcestershire CALC: A. Lodge reported that she had been unable to attend the last Area Committee Meeting, but that she continued to receive a plethora of uninspiring e-mails from CALC.

Previous Matters: The Clerk reported on various matters regarding which he had had a response from WCC as follows:

- a. Roundabout Swinesherd Way/Whittington Road: Armco-style crash barriers would not be considered for the area next to the roundabout, the existing pedestrian railings being considered adequate. SLB felt this response was inadequate and suggested further pressure be applied, supplying data obtained from West Mercia Police under the FoI Act.
- b. Drainage issues at Walkers Lane/Swinesherd Way junction: The area was inspected and no major issues were observed. The Council was asked if there continued to be a problem at this location. SM thought not, but the situation would be monitored in the future.
- c. Sunken Drains Church Lane: These had not been dealt with (2 outside "Bredon", 1 opposite drive to "Goldcliffe".
- d. Poles for DFS/VAS: Under investigation.
- e. Filling of Grit Bins: Programmed.
- f. Flooding near Wychwood, Pershore Road: The area of the B4084 outside the property would be inspected further.
- g. Glass on B4084, carriageway and footway: The glass spillages on the carriageway had been swept and a two weekly sweeping schedule instituted.

#### New Matters:

The shrub outside the Old Coach House was again obstructing visibility on Church Lane. The Clerk was to write to the owner.

### Traffic Management:

Previous Matters: The Clerk reported on two matters regarding which he had had a response from WCC as follows:

- a. Improvement of signing of Walkers Lane on Swinesherd Way: This would be assessed as part of the Speed Limit Review, and further information would be provided in future.
- b. Whittington Road: The 40mph repeater signs were looked at and the distribution of the existing ones was considered adequate. This was disputed by SLB

Speeding: The Clerk reported having attended a meeting at County Hall where it had been agreed that DFS/VAS had been approved for use on Pershore Road. WCC were to provide pole extensions as appropriate. DFS/VAS were not acceptable on Church Lane. It was suggested that the Council consider an alternative approach such as seeking a reduced speed limit (20 m.p.h.) Members agreed (MB/AL) - the Clerk was to write.
