At an Extraordinary Meeting of Whittington Parish Council held at Whittington Village Hall on Tuesday 10<sup>th</sup> February 2009, at 19.30 Hrs.

**Democratic Period/ Question Time:** Some 4 - 6 members of the public were present. A local resident commented on the poor state of the local roads, especially Church Lane between the Village Hall and Walkers Lane. She was advised that the Parish Council had already reported the poor condition of the road but without success in getting significant repairs put in hand. She was recommended to write to the Highway Authority, and copy her letter to WPC which would support her case.

The main reason for public attendance appeared to be the proposed WCFC stadium development and representations were received strongly opposing the development (City of Worcester Planning Application P08Q0652)

# **2009.21** Co-option of New Member to fill Casual Vacancy.

The Chairman had received an application from Mrs Ann Lodge, which he had passed to the Clerk. This was circulated to the Members present following which she was nominated by the Chairman, seconded by R.A. Phillips and elected unopposed.

The Clerk was to make arrangements for her to sign a Declaration of Acceptance of Office as soon as possible, but it was known that she would soon be going on holiday for 6 weeks.

WPC Response: Members had been made aware of the application and the electronic format thereof. A copy was available on a computer brought by the Clerk. However Members were generally well aware of the nature of the development (see meeting 8/12/2008 - no significant changes noted) and had been in a position to review the application previously. Taking note of Public's comments prior to the meeting members discussed the application. They were unanimous in opposition to the proposal being concerned upon its immediate effects on the village, long term implications for development to the East of the "by pass" road, up to the edge of the M5 motorway, and the variation from the Worcester City Local Plan.

In order to respond to a question from a representative of a neighbouring Parish the Chairman - with Members' agreement - suspended the meeting temporarily. The question was resolved and generated further public comment, following which the Chairman re-convened the meeting.

The Clerk was asked to submit a response objecting to the application on whatever relevant grounds he could identify, to be e-mailed to Councillors for their review and comment before submission. The Clerk indicated that their response would need to be immediate as the Council's response had to be submitted by 13<sup>th</sup> February.

The Clerk was instructed (MB/RAP) to write accordingly.
