At a Meeting of Whittington Parish Council held at Whittington Village Hall on Tuesday 13th November 2012 at 19:30 Hrs.

Democratic Period/ Question Time: Four Parishioners were present. One asked if there was any further information regarding the Uffnells Farm development. The Clerk advised that subsequent to the Public and Parish Council meetings relating to this development on 30th October the Parish Council's response had been submitted to the Planning Authority and he had no further information. A question was asked about the Village Centre (Pond Farm) development. The Clerk explained that the owner and his agent had intended to be present but had decided not to. The scheme was understood to be ongoing.

Another Parishioner reported on the problems of Parking in the village, his comments were endorsed by others, and the Clerk explained that the Chairman was aware of the problems and felt that this should be a matter for discussion and a co-ordinated response, and that he anticipated a further meeting might be called. Parking by school parents combined with the parking of large vehicles outside the church was reported as creating a potential problem of access for emergency vehicles.

A parishioner pointed out that remedial work had been asked for in respect of the footway at the B 4084/M5 Motorway J7 roundabout a very long time ago but that no action had been taken.
