a. New and Unresolved Planning Applications:

Application Number: W/13/00046/CU

Proposal: Change of use from agricultural land to domestic garden

Location: Land off Church Lane, Whittington

Applicant: D. Baker, The Great Redfield Trust, 28 Berkeley Close, Whittington, Worcs. WR5 2RF Comments: The Clerk reported that following the WPC meeting on 12th February, the misinformation contained in the application re WPC involvement had been pointed out to the Planning Authority and the Applicant. The letter had been published on the WDC website.

The Applicant had apologised for the error and explained how it arose; Members received a copy of this information. S.L. Brooker had also commented by e-mail to all Members; it was not felt that landowners in the village could be asked to suspend their plans for the sake of the Neighbourhood Plan. There had been no public response to the Clerk.

Members considered the application and had no objection to the proposal per se. They were however concerned at the possible future use of the land and asked that permitted development rights be withdrawn by a suitable planning condition, so that any permanent development in future would require Planning Permission to be sought. It was agreed (PJW/MB) that the Clerk respond to this effect.

2013.35 Progress Reports/Updates on Matters Previously Resolved.

The Clerk reported briefly on the Whittington Parish Neighbourhood Development Forum (WPNDF), a copy of the draft minutes of which had been sent to Councillors. He commented that in the draft application for Neighbourhood Planning Authority Status the Chairman seemed to have reduced the $2\frac{1}{2}$ year to completion figure picked up by some in attendance at that meeting.
