# 7. Police Officers Report.

Please find below the report for Wickhamford for 1st October 2019 to 12th November 2019.

- During the recent torrential rain the A44 between Broadway and Wickhamford has flooded causing driving conditions to be dangerous.

### 8 Items for Consideration:

- a. Burial Ground annual inspection. Cllrs considered a proposal from Simply Stone to carry out and annual inspection of all headstones and plots free of charge and work would be colour coded in order of urgency, ie. Red is most urgent then amber then green and a scale of £120 per job for urgent then £90 then £60. It is understood that as the years go on, the work will diminish. It was unanimously agreed to proceed with this. Cllrs also agreed to put a message in newsletter so that residents are not alarmed if headstones are repaired.
- b. EA drop in session- Well attended event and an individual property protection scheme survey was offered with suggestions of remedial work to be done. It came to light that the EA has no responsibility/interest in sewerage and this should be reported to Severn Trent, again, a message in newsletter advising residents.
- c. Section 106- Clerk has checked full details on planning application and the funds of £4415 must be spent on recreation ground. Next agenda to consider options and then ask residents for their views.
