County Council:

ITEMS FOR DISCUSSION.

- 1. Applications for co-opted parish councillor- 2 residents expressed an interest with 1 application being received. A vote was taken with 6 votes in favour and 1 abstention to accept Mrs Linda Hall as a co-opted councillor.
- 2. Memorial Hall- New cleaner is settling in well with no issues. Cllr Smith has arranged for door to be repaired. Committee has set up online banking and has asked parish clerk to be a signatory.
- 3. Land for village car parking-Cllr Appleby has had local discussions and has a plan for the majority of village events either with Bretforton Manor or himself. Any other events will be considered and arranged at the time of the event.
- 4. Flood planning-Cllr Smith has collected 35 bags and agreed to collect more. It was agreed to consider a central store at Community Shop but this would need social club permission so Cllr Cleveland will deal with this. No-one has come forward to be involved in the taskforce to date.
- 5. New footpath-Recreation Ground- Pictures of Offenham path have been circulated for consideration. It was agreed that this would be a good addition to rec ground and over time may result in the designated path currently through the pitches being relocated. Ask club to consider at their meeting and confirm.
- 6. Climate Emergency Action Day- Clerk has looked at 'easy wins' sheet and suggested that councillors look at it for next meeting, decide on 10 that could be done with a view to launching it in January 2021, current situation permitting.
- 7. Works on the green at The Cross No quotes have been received. Ask Ringway and Henson for quotes for next meeting.
- 8. Vicarage Nurseries- Nothing received to date.
- 9. SHLAA- Map sent out to councillors. Keep on agenda for further discussion when situation develops.

Wychavon District Council.

- **NHB Funding deadlines-** Deadline for allocating funds is 31st March 2021. Project for Musical Legacy may not be in a position to drawdown by the last available date. Therefore PC must consider another project such as pathway if this cannot be moved forward. It was agreed to ask for an update from Bretforton Silver Band, check up to date position from Wychavon and gather together information for path for next meeting.
- Nominations for Wychavon Chairman's Diamond Jubilee Community Recognition Award 2020-Cllrs need to agree on any nominations for November meeting but must be willing to submit a paragraph to Wychavon about nomination.

Bretforton Parish Council has no objection to the replacement windows on this application however it objects to the 2 storey extension for the following reasons:

It would be too close to the boundary of other properties and encourage overlooking, it is not appropriate for a barn conversion

Bretforton Community Social Club, 60 Main Street, Bretforton. Re-positioning of existing smoking shelter

Bretforton Parish Council has the following comments to make regarding this application:

The structure is within the conservation area and is an ugly looking structure, they are disappointed about the removal of the tree despite the fact that there is a replacement proposed on the planning application, they are also disappointed that the structure is a 'smoking shelter' thus encouraging smoking and being near to passersby and children using the club.
