ITEMS FOR DISCUSSION.

Allotments- Cllrs Davis and Cleveland attended a meeting with a landowner who may be interested in leasing a 2 acre piece of land at Back Lane. Clerk to obtain map to assess area and suitability.

Parish Plan- Information has now been collated but needs refining into a shorter version. Parish Plan information will be required for S106 applications. Cllr Grant agreed to look at format of questionnaire for businesses and organisations within village and recipients for next meeting.

Burial Ground-i. Audit of 2012 entries.- Cllrs Wright and Johnson audited records and entries for 2012 and confirmed that all were correct. They have annotated records to that effect.

ii. Memorial has been reinstated on graves 325 and 326. Clerk has requested paperwork from registrar to sign off work.

Amenity Mowing- Awaiting list from Worcs CC. Next agenda.

British Legion- Representative attended in Open Forum to advise of up to date position of Legion. Requested from head office that they move away from British Legion and become a social club. This will need approval of members. Financial situation is poor with very few members renewing. Requested that PC is kept informed.

Trees-i. Station Road. Quotation received from Arborvale for work. Awaiting quote from Ancient Oaks. Next agenda.

ii. Jubilee planting has been completed. Clerk has received a couple of complaints from residents about location of trees.

Request for Grit Bin/Salt. A request has been received for a grit bin on Main Street at the corner with the lane. It has been suggested that 3 locations may benefit from bins. Diary for July to assess sites and order.

Section 106- Clerk & Cllr Cleveland met with Jem Teal from Wychavon to talk about projects that could be implemented with S106 funding. Monies can be available to Bretforton if they support the criteria in the four areas. Monies have to be spent within 5 years and S106 is likely to be phased out in 2014. Request that Jem attends next PC meeting.

Telephone Box- Request received from resident asking that box is removed as dangerously leaning. Clerk to ask BT for timescale for power disconnection and therefore removal. **Littlebrook Nurseries-** Clerk has received email requesting information on Parish magazine and hall to arrange village consultation for possible development at Littlebrook Nurseries.

Bretforton Community Alliance- Underground Watercourse. Possible underground watercourse has been identified at end of Fallon Lane causing fields to flood. Cllr Wright will contact Land Drainage Officer, Wychavon and Environment Agency to assess action to be taken.

VAS- Clerk has contacted Westcotec regarding supplying VAS at a cost of £2625 +vat. There would be an additional cost of £80 for extra bracket. Maintenance would be at a cost of approx £90 per month, to change battery and move location. Proposed to ask local PC's if they would be interested in sharing device.

Post Office Closure- It was proposed and agreed to hold a village meeting during w/c 18th February 2013 at British Legion to gauge interest from village in running a community shop facility. Presentation to be done by Cllr Smith along with Cllrs Lisney, Grant and Cleveland. Clerk to arrange room at legion and notice to be put in Community Alliance newsletter.
