#### 8.10 Election of Chairman and signing of Declaration of Acceptance of Office

**Council unanimously resolved** (RG/CH that in the short term reserves, as per the tabled Report to Council, should be re-allocated to facilitate cash flow whilst VAT is reclaimed.

# 8.18 Borrowing approval and submission of a loan application

- 1. Proposal: **Council unanimously resolved** (SP/MR) to seek the approval of the Secretary of State for Housing, Communities and Local Government to apply for a Public Works Loan of £446,000.00 for up to 50 years, to meet capital expenditure costs to enable the Parish Council to build a new village hall at Vardroe Way, off Hawthorn Rise, Tibberton. The estimated annual loan repayments will be £21,229.60
  - It is not intended to increase the precept for the purpose of the loan repayments
- 2. Proposal: **Council unanimously resolved** (JP/RG) to delegate to the Clerk (in consultation with PCllr S Pearson and PCllr M Rowley) completion of, and submission of, a loan application to the Public Works Loan Board for a Public Works Loan for £446,000.00 for a period up to 50 years when confirmation of borrowing approval had been confirmed.

## 8.19 Appointment of a Quantity Surveyor / CDM Principle Designer / Clerk of Works

Proposal: **Council unanimously resolved** (EH/RG) to appoint D P Design Partnership to fulfil the role of Quantity Surveyor / CDM Principle Designer / Clerk of Works. Contract to be signed by PCllr S Pearson and PCllr M Rowley (Clerk to action).

#### 8.20 Acceptance of Wernick Quotation for the building of a new Village Hall

Proposal: **Council unanimously resolved** (CH/RG) that PCIIr S Pearson and PCIIr M Rowley be authorised to sign the build contract with Wernick Ltd (dated 11/6/2018) as soon as possible after 1) borrowing approval is granted by the Ministry of Housing, Communities and Local Government and 2) confirmation is received from the Public Works Loan Board that they will provide a loan of £446,000,000.

## 8.21 Amendment to Minute 1.15c 9th January 2018

Proposal: **Council unanimously resolved** (JP/EH) to amend Minute 1.15c, 9th January 2018 as stated in items i) and ii) below:

- i) Membership of the Working Group to comprise the Clerk to the PC, PCllr Seth Pearson, PCllr Margaret Rowley, PCllr Rob Grimer and Brian Walford, co-opted member of Tibberton Community Land Trust
- ii) To delegate to the Clerk all executive powers and responsibility for actioning and progressing all matters associated with overseeing the building programme and the settling of related financial obligations in relation to the furtherance of that building. Clerk to report to each meeting of Council and each meeting of the Working Group.
