1. Apologies:

Apologies were received from Cllr George Harrison

2 Declarations of Interest:

Councillors were reminded of the need to:

- a. update their register of interest
- b. to declare any Personal interests in items on the agenda and their nature
- c. to declare any prejudicial interests in items on the agenda and their nature.

3. Minutes:

The minutes of the Parish Council Meeting held 17th January 2011were approved and signed as being a correct record.

4. Clerk

a) Progress Reports on actions from minutes 17th January 2011

i. Insurance damage claims The Green

Accident 10th Nov 2009. Clerk still chasing recovery of £125.00 excess from insurers, Allianz.

The Chairman noted the forthcoming renewal of the Council insurance and requested the Clerk check the renewal documents, in particular in relation to any required declarations for Councillors over the age of 75 years.

ii. Highways, Hedges, Potholes

- a) Grit Bins In preparation for the coming winter the Clerk is to request councillors to identify locations of existing grit bins and new bins, to see if they meet the WCC criteria for issue of free bins and if not ascertain costs to the Parish Council.
- b) Pear Tree Inn at Smite No response from hotel owners received to date. Clerk to write, Recorded Delivery, to Owners and if no response, then to refer the matter to Highways Dept at Worcs County Council.
- c) Overgrown hedgerow Pulley Lane The land in question to north side of Pulley Lane, is owned by the Woodland Trust and is within Droitwich Town boundary. Clerk to refer matter to Clerk of Droitwich Town Council.

Hindlip Lane junction with Pershore Lane – Action brought forward from previous minutes. Clerk to pursue Highways on the continuance of double white lines up to the lane junction to prevent cars overtaking as cars pull out of the lane.

Middleton Bridge – Clerk to follow up with Highways Team the required repair works to the posts and barriers.

- **iii.** Lengthsman Scheme Clerk provided an update on work carried out to date under the Lengthsman Scheme. Some final invoicing for the current financial year still to be received to cover works carried out in recent weeks. Clerk to submit invoice to Worcs CC to recover costs within the grant allowance of £2,517.
- iv. Court Farm Enforcements It was agreed the District Councillor should take up the matter of long outstanding Enforcements and ineffective resolution of the issues. IN/09/02978/LB Court Farm Dairy Building Listed building IN/09/00577 Court Farm removal of tiles, deteriorating of buildings within the curtilage of the Dairy Listed Building.
- v. Worcester Rugby Club Signage A retrospective planning application has now been received for the advertising hoarding. Councillors expressed their concern over the poor quality of the documents forwarded by the Wychavon Planning Dept.
- vi. Parish Council Elections The Chairman drew attention to the Qualifications and Disqualifications regarding nominations for election of a Parish Councillor.
- vii. Royal Wedding Celebration 29th April 2011 P.Cllr D Luscombe reported on the joint committee arrangements for the celebrations from 10am to 4pm. Due to generous donations from two local residents all costs of hire of hall, marquee and live big screen are covered. It was felt that parking would not present a problem.

There will be no charge but residents need to apply for tickets to establish numbers for insurance and capacity regulations. The broadcast of the wedding commences at 11 am in the marquee and all bring their own picnic lunch.

At 3pm everyone to assemble into the village hall where the W.I. will provide tea and cut a large tiered Wedding Cake and serve Ice cream. Music will be provided by local musicians 'Finesse'.

b) New items

i. Dog Control – Public Rights of Way

Complaints had been received from Walkers with dogs on Public Rights of Way crossing private land. Public must be aware of the landowners rights for their animals.

Dogs must be under control on a lead by the side of the owner and not allowed to run free, foul or stray off the designated footpath. To take or allow dogs to stray onto surrounding private land constitutes trespass.

The matter cannot be dealt with by the Parish Council as it is a legal issue between the individual private parties.

iii. Droitwich Area Partnership

P.Cllr P Edwards reported on a meeting attended on 16th February 2011. It is a Strategic Partnership with £30,000 funded annually by Wychavon District Council to support grants to voluntary organisations to engage within the wider public in Droitwich and the surrounding 28 parishes.

iv. Planning documentation changes

In line with E-Government guidelines the Local Planning Authority is obliged to receive applications in CD or Paper format or electronically through the planning portal. The Local Authority is unable to force Agents/Applicants to submit hard copy documents.

It was felt that the District Council has a responsibility to consult Parish Councils on planning matters and that major or contentious developments cannot be dealt with by councillors viewing individually a set of compact discs. The council does not have the financial resources to own IT PowerPoint equipment and has to hire its meeting room. Hard copies of plans are required to display for Public meetings and Exhibitions and would not be able to carry out its duties of public transparency on planning matters.

4. Chairman

- a), MP Peter Luff was invited to discuss with Salwarpe Parish Councillors how best we could
- b) invoke his support in our endeavours in objecting to major development proposals impacting on
- & c) Salwarpe Parish.

Discussed: (1) Copcut, (2) Yew Tree Hill, (3) Tagwell Heights with two Barrett Homes sites off Jackdaw Lane and land alongside M5 motorway at Clink Gate, (4) Newlandhurst Home and grounds. All the proposals will access onto lanes within the parish and the infrastructure required will lead to over development of the Droitwich southern area with a loss of its distinctive character.

A meeting with respective Planning Officers, District and Parish Councillors has been arranged for 25th March at Pershore to discuss the issues involved.

d) Gloverspiece, Salwarpe

P.Cllr D Luscombe reported on a meeting with the Chairman and residents on 15th February 2011 regarding the increased activities, structures and fencing, since planning permission W/07/01766 with conditional approval to preserve the amenities of the locality being used only privately and not used for trade or business. The issues and concerns will be investigated.

e) National Speed Limit Survey

D Cllr Miller reported that the County Council Highways had undertaken a survey of roads and had incorporated the A38 and surrounding roads in our area, it being a requirement to provide infrastructure for future developments to 2030, the report has been delayed until June 2011.

f) Old Poultry Farm, Drury Lane

The report by the Vice Chairman on recent communications with Agents acting on behalf of the owners of the site had been covered by the Chairman's report that following circulation of a questionnaire to residents a Public Meeting had been arranged by the Agents on 14th April 2011.

7. District Councillors Report

- i. D Cllr Tony Miller was requested to look into the basis of how a grant was given by the Droitwich Area Partnership to an individual in the parish.
- ii. Wychavon Housing provision figure up to 2030 is expected to be 20% less that previously quoted however the Local Authority has not achieved the required provision of a 5 year housing land supply and provide deliverable sites up to 2020.
- iii. The abolishing of the WM Regional Strategy had left an interim period not covered by the existing Local Plan up to 2011 and the replacement South Worcs Development Plan which has yet to be approved by 2013.

The Localism Bill will not come into force until 2012. Developers are taking advantage of this unplanned gap by submitting major planning applications putting pressure on the Parish Councils having to deal with the consultation process.

iv. The Land Drainage Inspector had been requested to investigate the source of sewerage draining into Martin Brook within Martin Hussingtree.
