#### 8. Items of parochial interest

- 8.1 Bus service consultation regarding potential service reduction MB reported that no decision will be made prior to June and there will be no cut backs before September.
- 8.2 The two local residents in attendance raised their concern about the security fencing that was installed in the last few weeks along the stretch of track running to the north of Droitwich Spa. The fencing is erected in a rural area and runs across otherwise open fields where the railway line had previously blended into the landscape. Residents understand that the fencing has been deployed in an attempt to eliminate cable theft from the line however the fence is unsympathetic to its' surrounding countryside, being shiny silver, the fence reflects sunlight and presents a visible scar across the land. The site is outside the parish but visible from the surrounding area including Elmley Lovett.

Several residents have reported the issue to Network Rail, the District Council and to Peter Luff MP. They are unhappy with the responses they have received with the exception of the MP who advised them to lobby the local parish councils to support their case.

ST instructed to write to Network Rail and DEFRA.
