It was unanimously agreed that the Minutes be signed as a true record.

5.1 The payment of the month's bills was unanimously agreed

5.2 The Bank Reconciliation as at 31st August 2013 was unanimously approved

5.4 Following the meeting of all members last week, groups will formulate budget requirements and pass to Cllr P Harvey this month so a draft budget can be prepared for November

5.5 It was decided to offer a grant of £200 to support the young Blackwell resident on her guiding expedition

#### 6. PLANNING COMMITTEE REPORT

6.1 The minutes of the Planning committee held in September were approved.

6.2 Neighbourhood Plan

Mary Green from Alvechurch PC will speak at the forthcoming meetings on Weds 9th and Saturday 12<sup>th</sup> Oct to share the experience of Alvechurch in

developing their plan. Burcot is to be included within the boundary of the Neighbourhood Plan. The next task is to specify the area for acceptance by BDC.

## 7. HIGHWAYS & ENVIRONMENT GROUP REPORT

7.1 Cllr Eales reported that she has trays of wildflower plants and seeds, some of which can be planted in October. Cllr Forknell to see if he can find some volunteers to plant once cemetery has had its final cut. It was agreed to get quotes to cut back the pavement from the Trinity Centre to High House Drive so that it does not deteriorate.

7.2 The decision relating to the provision of a Blackwell bus shelter was deferred and a site meeting with the residents will be arranged

7.3 It was agreed to purchase grit for Ron Rand to use around the parish and to fill our green bins. It was further agreed to add a note in the December newsletter pointing out that grit is for Highways use, not for clearing private driveways. The newsletter will also offer help with salt and clearing to vulnerable residents. The exact wording will be agreed before print.

7.4 It was agreed to try and make our tree warden feel more involved with the parish council. EO to deliver an invitation to the Parish Walk

## 8. SOCIAL SERVICES & COMMUNICATIONS GROUP REPORT

8.1 Cllr King reported that the church had agreed for us to have a permanent christmas tree at Blackwell. EO to meet with Cllr Forknell and an electrician to obtain quote for supplying electricity (nb PCC meet on 22<sup>nd</sup> October and would need to agree this)

The purchase of additional lights for use on lampposts was discussed, but dismissed, due to cost, not having our own lampposts, and there being no obvious sites for them. A 'Best Decorated House' was suggested for Christmas 2014 to be promoted through the newsletter.

The EO was asked to write to the new head teacher at Lickey School, welcoming her to the parish, and requesting an appointment to meet.

The formation of a Youth Council, and/or the provision and funding of a youth club was suggested but this will be put on next months agenda. Cllr J Harvey will circulate some information from NALC and Clent PC to consider

8.2 It was agreed that all refreshments purchased for Parish use be Fair-Trade. This is as Bromsgrove has achieved Fair-Trade accreditation
