Its merit at this stage was to provide a broad framework within which the final objectives might sensibly be set out.

The Chair advised that CPRE are unable to provide training as their remit and funding runs out on 31 March 2013 and they are fully committed prior to then. The Executive Officer was asked to seek alternative training opportunities.

It was agreed to ask Mike Dunphy, or nominee, to attend a future meeting in order to take the Committee through District Council documentation relevant to the Neighbourhood Plan.
