## **3. Adoption of the Minutes of the previous meeting**

The draft Minutes of the meeting held on 4th July 2023 were accepted as a true record of that meeting and were signed as such by the Chairman of the meeting.

## **5. Report from District and County Councillors**

District Councillor Jennie Watkins said that she was currently dealing with a number of planning issues and these were influenced by the fact that the South Worcestershire Development Plan was not yet in force. It was evident that MHDC had less than a 5 years' housing supply – it was in fact 3.7 years' – and this tilted the balance in favour of developers. She said that where individual communities had clear ideas about how they wished to see their locality in future the compilation and adoption of a Neighbourhood Plan would give comfort because it was considered by the local planning authority as a material planning consideration.

She had also noted that the government's adoption of an objective of Net Zero was now starting to have an impact in planning matters.

## **6. Report from the Parish Footpaths Officer**

The Parish Footpaths Officer was not present but reported through the Chairman that there was nothing of significance to bring to the Council's attention.

The Chairman reported that following the inclusion of work on footpaths in the Lengthsman's permitted activities she had arranged contact between the Parish Footpaths Officer and the Lengthsman in order that a plan for resolving outstanding footpath issues might be developed.

The Chairman reported that she had requested Operation Snap signs which would be placed in Eldersfield.

She was also of the opinion that the erection of the gates at either end of Corse Lawn were having the desired effect of causing motorists to reduce their speed.

The Clerk reported that the children's pads in the defibrillator were due to expire soon and it was therefore **RESOLVED that the Clerk purchase replacement children's pads.**

## **10. Lengthsman**

The Lengthsman had presented a list of issues which had been circulated prior to the meeting; the Chairman undertook to review these and progress as appropriate.
