2. Members' interests

3. Adoption of the Minutes of the previous meeting The draft Minutes of the meeting held on 6th October 2018 were accepted as a true record of that meeting and were signed as such by the Chairman of the meeting.

4. Matters arising

Reports from District and County Councillors

District Councillor Bronwen Behan reported that

- the timetable for refuse collections over the Christmas and New Year period had been prepared and was being issued;
- there had been a spate of opportunistic burglaries within the Parish, mainly from outbuildings; she advised residents to take especial care to secure their possessions;
- the South Worcestershire Development Plan had called for the proposal of sites for consideration for potential development; two sites within the Parish (both in Corse Lawn) had been put forward;
- animal boarding kennels and other animal-related commercial activities were being • brought under one licensing authority.

Members noted the report received from the Police and circulated prior to the meeting.

8. Broadband

The Chairman reported that he had now sent emails informing respondents to the questionnaire of progress to date; these had gone to all who had provided him with their email address, a total of 98. Of these, 27 emails had bounced back but from the remainder -71 - he had received 51 responses, all of which were positive.

He further reported that:

- he had asked Openreach for a breakdown of the costs in order that a view might be taken on how much, if any, of the work could be undertaken by local residents, thereby reducing the cost;
- Gigaclear had not yet been granted permission to lay fibre cable in Worcestershire, because of a 'dispute' with WCC;
- a company was installing a wireless service in Maisemore, although he understood that they were attracted in large measure by the business park;
- Worcestershire 5G Consortium were based in Malvern and were developing a next generation solution; he had offered Eldersfield as a rural test bed;
- it continued to be his aim to call a public meeting but the information currently available did not justify that step being taken at present.

9. Neighbourhood Plan

The advantages and disadvantages of producing a Plan, described at the last meeting, were summarised.

Within the county it is understood that there are seven Plans in place with two in preparation.

A Plan would make clear what it was about the Parish which Parishioners liked - and should therefore be protected and retained - and what they disliked - and which should therefore be improved or eliminated. Identifying this information would take time and effort; assistance from volunteers would be invaluable. It was also recognised that assistance from people with expertise in specialist areas would considerably enhance the value of the Plan. Parishioners who are interested to know more are invited – without commitment - to contact the Clerk.

10. Defibrillator

Councillors considered the proposals for the acquisition of a defibrillator before them but decided that without further information concerning the training which could be provided under one of the options it would be unsafe to proceed. The Clerk was instructed to seek further clarification of the offer.
