It was RESOLVED that the draft minutes of the meeting of 5 November 2015 were a true record of the meeting and signed.

04/16 District Councillor Report included

- Adoption of SWDP- 2 February 2016- if approved by inspector.
- Further officer changes in MHDC with new Monitoring Officer and staff reduction in planning enforcement.
- Aim to arrange visit by Chief Executive to the Morton ward hopefully May/June. Cllrs to consider any particular areas in the parish to visit as part of the itinerary
- Revenue Support Grant is less than expected and this will impact on budget deliberations although there is commitment to front line services.

This raised question re expectation of Parishes with reduced funding and in response there will be a likely impact on planning and refuse resources. MHDC as rural authority is able to increase council tax above the rate of inflation (not restricted by 2% capping) up to £5 per property which could result in a 3.6% increase for Band D property.

05/16 Footpath/Highway/Lengthsman Reports

Lengthsman -Acknowledgment to the work of the Lengthsman and supporting councillor especially in the recent wet weather with maintenance of culverts and grips and updating all records.

Highways – as per report and:

Visual display of recent flash flooding and further drainage work required.

Footpath- Cllr Flanders in possession of parish map. Agreed to publish a notice in parish magazine requesting support in walking and surveying parish paths. Still no appointment of a WCC officer for the SW Worcestershire area. AGREED Cllr Flanders has delegated responsibility to pursue footpath matters with footpath warden, liaise with Welland officer and thereby raise awareness of parish footpaths.

06/16. Broadband (BB)

Worcestershire Superfast Broadband Phase 1 & 2 in the parish well under way although hampered in places with physical issues. £3.25m extra to spend beyond phase 2. Questionnaire now available for householders to complete seeking comments on broadband service presently available. The results will be sorted as per those within the planned phases and the remainder hopefully will be considered for improved service using this extra funding. This questionnaire will be promoted in the parish magazine.
