# 49/18 District Councillor Report

The following was reported:

- The Council with Wychavon, is seeking a joint Head of Housing and Communities.
- This new role will involve working with housing associations and exploring potential changes to the private rented market through the development of new housing companies.

- The **alternative weekly waste collection service** running well after nearly three months. Noticeable increase in recycling.
- £250,000 to be spent the on the listed **Council Chamber** on restoration and underpinning.
- **Governance arrangements** set to be reviewed. That is, how the elected Council works and how effective is the present structure. Questions like; does the committee system work properly? Should we have more elected councillors or fewer? What value do the leadership and portfolio holders add to the process? Is the decision-making process modern and effective? Any comments please address them to DCIIr. Mick Davies.
- Hefty fine for ignoring fly-tipping investigation Fly-tipping is a criminal offence and it is
  illegal to obstruct authorised officials in the investigation of an environmental crime as
  highlighted in recent case.

#### 52/18 Highway

Noted that many hedges are growing vigorously and those on roadsides/junctions may become a visabilty hazard. If this is the case owners will be notified seeking their support in cutting them back.

The recent good quality of highway repairs was noted in the area of Chandlers Cross, Druggers End and Cutlers Lane. Also reported that the small triangle of land at the junction of Chandlers Cross and New Road had also been tarmac'd and such action not considered unreasonable by local residents. WCC highways was subsequently asked to reinstate the triangle of grass land by Malvern Hills Trust.

**18/534/FUL** Further information provided by applicant regarding location of foothpath incorrectly identified on original application reference definitive footpath map. The footpath which has been used for many years is identified with stile and finger post and passes the right hand side of hedge

boundary. The definitive map records the path on the left hand side following a route directly across the front of the newly converted barn and presently accessible through a private gate with dogs running loose within the curtilage of the property. After discussion it was **agreed** this was an opportunity to recommend seeking a legal adoption of what was already a widely used alternative path and so not inconvenience the occupiers of the newly converted barn for the future. It was also noted that warning signs as regards the presence of dogs had been erected either end of the presently used footpath which crosses privately owned land. It was agreed that the footpath officer would discuss these signs with the owners of the property.
