

Minutes of the Parish Council meeting held on Monday 4th November in the Village Hall

96.13 **Apologies:** Apologies were received and accepted from County Councillor P Grove and Mrs A Jackman

97.13 **Declarations of Interest:** There were no declarations.

Democratic Period/ Public Question Time: -

Martley Pre-School reported that their numbers were very low and they needed to recruit new children. Martley Court owner had given permission for their banner to be placed on the rail. District Councillor Williams suggested that the pre-school apply for a grant from the Grammar School Charity.

The owner of Martley Court said he was shocked that the Parish Council had started to work on the hedge in the centre of the village. Need to clarify ownership of hedge asap and keep Mr Albutt informed. Mr Albutt handed Cllr Gardner 2 copies of a map of his boundaries from his deeds.

99.13 County and District Councillors Reports:

District Councillor Williams reported that the Fair Energy Scheme is still open. She reported that Phase 1 of the SWDP Independant Examination was completed and that the inspector said that 36,000 houses are needed in South Worcs not 23,200 as proposed. SWDP not yet adopted. She also reported that MHDC does not have a 5 year land supply under the NPPF.
