27/21 Apologies

To consider acceptance of apologies for absence from Councillors: There were none.

29/21 Reports from other representatives

To receive reports from County and District Councillors, Tree and Footpaths Wardens and other representatives:

District & County Clir. Prof John Raine reported that WCC had agreed next years budget. He was to meet with Hannah Davies, the Highways Liaison Officer, and would discuss the inappropriate parking at St James Close and it was agreed that the Clerk should write to highlight the issue. A site visit to Adelaide House had been arranged for 15th March and it was expected the planning application would be considered at the Southern Area Planning Committee Meeting on 24th March.

No further information had been received regarding the derelict house on Nabs Pitch and the enforcement team was attempting to contact the contractor at the Lamb Inn site.

He had also met with Herefordshire County Council and the Malvern Hills Trust to discuss parking at the Wyche. It had been agreed to encourage parking at West of England quarry to ease congestion on the highway.

Charles Penn, Malvern Hills Trust reported that there had been an extension to car parking passes until end May. The Trust had also noted an increase in walkers on the hills during the latest 'lock down'. He also confirmed there was a vacancy for a trustee from Priory Ward and also for a new warden due to retirement.
