County Cllr. McVey had requested the Parish Council consider footway maintenance priorities. It was agreed to recommend that works to Ebrington Road were undertaken prior to those on West Malvern Road.

It was noted that there was a good deal of surface water on Lower Road and this may be due to subsurface streams following recent prolonged heavy rain.
