Land Drainage Partnership is followed."

Cllr. Turner confirmed that the consultation process over improvements to the playing fields was well underway and several suggestions had been made. This subject was to be the main topic of the Annual Parish Meeting.

34/19 Allotments & Community Woodland

Update on measures to protect allotment fence: The Clerk and Chairman had met with Nick Hands, the director, of Malvern Outdoor Elements who had indicated that his preferred solution was to create an 'offroad' parking bay for one coach from the grassed area adjacent to the bungalows. This land was owned by Fortis Housing and the Clerk was to write outlining the proposal for their consideration.

The Clerk hoped that the new path in the woodland would be completed by the next meeting.
