1. ELECTION OF CHAIRMAN

Cllr. Craig was unanimously elected as Chairman and he duly completed his acceptance of office.

It was noted that the planning application for 59 houses off Mayfield Road, near its junction with North End Lane was still to come before the Southern Area Management Committee. The Parish Council had raised concerns over the probable increase in traffic along the section of North End Lane through Madresfield, but their suggestion for an 'access only' designation had been refused. Further correspondence was to be sent to Highways expressing concern. Newland Parish and Malvern Town Council were also to be approached for support.
