# 4. Confirm the minutes of the meeting held on 15th February 2011

a) Lengthsman's end-of-year accounts.

# 7. Village Facilities - possibilities for support or intervention. Review the Public Meeting held on 12<sup>th</sup> March and consider what action can now be taken.

Some 130 parishioners had attended the Open Meeting on 12<sup>th</sup> March and 18 had volunteered to help in forming an Action Committee. After a discussion it was agreed that Cllr P Tebbit would chair a committee to consider establishing a plan of action with these 18 volunteers, or as many who could attend, at a meeting on 30<sup>th</sup> March in the Village Hall. Cllr Tebbit together with the clerk would formulate an agenda and proposed terms of reference for this committee and

Cllr Tebbit would circulate a document for discussion setting out the possibilities for the work of this committee.

The clerk would make the necessary arrangements re agenda and formal notices.

### 8. Consider a response to WCC regarding the removal of Bus Services to and from the village.

The clerk was asked to respond on behalf of the Council stating that the removal of the last public bus service to the village would be a considerable inconvenience to many elderly residents who did not have access to private transport and would be a further downward step in depriving rural communities of vital communal facilities.

Cllr Tebbit reported that the proposed draft document had been discussed and the general agreement at the meeting was that it was rather one-sided. It was referred back for review and would be considered at a future meeting.
