  After agreeing to pay this substantial amount the council decided to review the whole matter of the Lengthsman project at its next meeting.
- e) Consider supporting the 'Show Committee in the installation of a defibrillator unit at the Village Hall by a direct donation or purchase of the equipment.

It was agreed to purchase the defibrillator for the Show Committee and make a donation of £300 to the associated costs of installation. The clerk was asked to contact County and District Councillors to request that they support this project from their discretionary funds.

- i) War Memorial, Whilst the inscriptions are readable he would obtain a quotation for cleaning the letters to improve legibility.
- ii) Donation in memory of Kip Williams, Kip's husband Gwyn plans to install a seat in Lulsley Churchyard where her ashes are interred. The council agreed a contribution of £100 towards this in her memory.
- iii) Litter Bins, He now had specifications of the MHDC preferred bins and would prepare a costing for the replacement of the two bins in the centre of Alfrick.
- iv) Notices on the Memorial Green, Speakers at the Parish Meeting had indicated that the collection of placards on the Memorial Green detracted from the dignity of the location. Councillors asked the clerk to request those using this location to desist.
- v) Dog fouling, Biodegradable paint would be obtained to enable offending items to be marked (as last year) to try to persuade dog-owners to clear up after their dog.
- vi)Playing Field Pavillon, Whilst this was not a hazard it was in poor repair. He would establish details of legal ownership and asked councillors to visit it and consider a course of action at the next meeting.
- vii) Next Newsletter. Members considered a half-yearly Newsletter appropriate rather than the quarterly requirement of the now defunct Quality Parish standard. He was asked to prepare and circulate a draft letter for review.
