### County Councillor Report, January 2024

1. The County Council, like virtually all other local authorities, is experiencing increasing costs in general and in three expenditure areas in particular. Adult Social Care, Child Care Placements and Home To School Transport are seeing costs escalate, resulting in budget pressures which the Cabinet are addressing as a priority.

The Council is determined to not only maintain key services but to continue to provide the enhanced services which it has committed to do. It doesn't help when the government fail to maintain council grants in line with inflation and limit the increases that Council Tax can be increased by each year. For example, the Chancellor of the Exchequer can increase national taxes at will, to ensure "a balanced national budget", but local authorities are limited to a 3% rise in Council Tax each year, at a time when inflation has been running at over 10%.

- There is also a 2% increase which is ring fenced for Adult Social Care.

I will keep you updated as the Council prepares its Budget for 2024/25.

2. The County Council has secured £1.1million to help speed up hospital discharges, boost social care provision and prevent avoidable hospital admissions. Local Councils with Integrated Care Systems (ICSs) and identified by NHS England as experiencing challenges with urgent and emergency care, were invited to put forward proposals for access to a £40million government fund. Worcestershire County Council were successful and will use the additional money to buy more services aimed at keeping people out of hospital as well as more packages for care at home
3. A new bursary to aid young people with special education needs or disabilities is being made available by the County Council. The £1,000 Supported Internship Bursary will be for those partaking in the Supported Internship Programme. The fund will aid learners in acquiring work essentials such as PPE, uniforms, IT equipment and travel support.  
The Supported Internship Bursary demonstrates the County Council's determination to fostering the growth and development of the county's future workforce and championing employment inclusion.

**Malvern Hills District Council Report (January 2024)**

### Home Upgrade Grant Scheme

Free home improvements are available to residents in Worcestershire.

Worcestershire County Council has received Government funding as part of the drive to save energy and make homes warmer.

## Eastham Parish Council

The Home Upgrade Grant scheme (HUGs) is designed to tackle colder homes that do not have mains gas central heating. Homeowners and tenants in Worcestershire could benefit from a variety of measures to help reduce energy bills including internal and external wall insulation, loft and cavity wall insulation, air source heat pumps, solar panels, draught proofing and many more. To qualify, households must not use mains gas to heat their home, and have a gross annual income of less than £31,000 with a current Home Energy Performance certificate (EPC) rating of D to G.

Funding is also available for landlords in the charity and private rented sector.

Those who qualify for the scheme, will undergo a free technical survey to see which improvements would be most suitable and help improve energy efficiency the most.

Worcestershire County Council is working in partnership with local energy charity Act on Energy, along with Redditch Borough Council, Bromsgrove, Wychavon and Malvern Hills District Councils to deliver this programme.

### **Community Projects**

There are four projects on Malvern Hills Crowdfund page that are currently raising funds and need help reaching their target.

- Kyrebrook Daycare Centre in Tenbury is hoping to raise £37k to launch a new friendship and lunch club giving socially isolated people the chance to make new friends and connect with old ones.
- Martley Cricket Club is hoping to raise £118k to create a new Sports and Cricket Pavilion for the Martley Community.
- Maggs Day Centre is hoping to raise £45k to provide outreach workers that will engage with rough sleepers and help them gain accommodation.
- Newtown Sports CP and PAN Disability Football Club is hoping to raise over £2.8k to expand their football club to disabled children within Malvern and the surrounding area.

### **Signage Review**

Following on from a signage review commissioned last year, Malvern Hills District Council is working with Worcestershire County Council to improve road and pedestrian signage. A comprehensive programme of works to declutter and improve existing signage is underway with Tenbury area to be completed by January 2025.

### **Create a Coronation Community Orchard**

Local communities could receive up to £10,000 towards the cost of a Coronation Community Orchard through a new tree planting grant.

Between £200 and £10,000 is available to support the creation of community orchards within the district, including costs for trees, protection, fencing and installation. The aim of the fund is for local community orchard creation projects to provide a lasting commemoration of the Coronation year, and to further the King's lifelong work conserving the natural environment.

The Government has provided a total of £2.5m in funding to local governments, through The Coronation Living Heritage Fund (CLHF), which celebrates the coronation of King Charles III and supports tree planting projects across England.

Malvern Hills District Council is inviting applications from groups including schools, residents' associations, community groups, charities, businesses and parish/town councils to create community orchards on private or public land, which provide community access and engagement opportunities.

### **Paperless Bills**

More than 9,000 households in the Malvern Hills District already receive their annual Council Tax demand by email but thousands of people are still receiving paper copies, even though going digital (if possible) is a faster and more convenient option.

Those who switch to e-billing will get their bill and other related communication, faster and will also be helping the environment by reducing their carbon footprint. Residents who have opted to be contacted by text or email will receive messages asking them to make the switch. The message will come from Malvern Hills District Council and contain a link people will be asked to click. Once clicked, they will be taken to a page which asks people to confirm they want to sign up from e-billing, asks then for their email address and their Council Tax number. Report on Items of Interest 22 January 2024

## **Flood Defences, Tenbury Wells**

Another near miss for the Town. The Environment Agency trundles on and we have a few years of risk for the Town before Scheme completion. A big flood in the meantime and various businesses have announced they will leave or fold - they can no longer get insurance.

The recently announced Government Flood Recovery Framework could give a flood-hit Tenbury business up to £2,500. I have talked to one local business where their recovery sum from the 2007 flood was over one hundred times that. I have written to our MP asking her to lobby for Government backed flood insurance for the premises designated to be covered in the Tenbury Flood Relief Scheme until the Scheme is completed.

Planning. MHDC

MHDC's performance reporting highlights problems in Planning. Starting in May, I asked for data on the Department's productivity, some months later this was confirmed as unavailable. I have asked for a summary of what Planning considers are the problems, I await a reply. The matter of Planning was raised at the last full Council Meeting with no admission of a problem. The next stage in the Flood Relief Scheme is Planning.

## **Speeding**

West Mercia Police have agreed to Operation Snap and the signs are up in the Rochford area and more recently we have added Hanley.

## **parkrun**

We are close to our funding target for the Junior Tenbury Event. I await pledge details from Tenbury Town Band and one of our local businesses to see exactly where we are. The parkrun Ambassador tells me that the necessary team is almost in place. I have started looking at possible routes for the Senior event. Should we overshoot on Junior funding, I will be proposing any excess pledges are put towards the Senior event.

## **Teme Bridge**

Acceptance, now, that the Bridge is no longer fit for purpose, Worcestershire County Council has corrective alternatives, such as a footbridge, "under active review". To add to the four pedestrians hit by traffic on the Bridge, a cyclist has now been hit. All reported to County, we trust they see the urgency in the situation.

## **Road Works**

I continue to investigate the methodology and timing of road works and whether the current balance of disruption and contractor convenience is correct in Worcestershire and Shropshire.

## **Tenbury Pharmacy**

I find that some individuals and groups are taking their trade to other towns, local stakeholders concur. The Tenbury pharmacy is part of the Phoenix Healthcare group, the largest private healthcare group in Europe. I continue to investigate.

## **One-Stop-Shop**

Cleobury Mortimer provide their full range of community services on set days each month so that people seeking help on multiple issues can get help "in the round"; they did a pop-up in Burford using the same format, just across the river. Worth us considering?

## **Electric Tenbury?**

Electric vehicles, we are assured, are the future. We have grid capacity in Tenbury for fast chargers to attract these more affluent drivers. The matter is with Tenbury Town Council.

## **Neighbourhood Plan**

Tenbury Town Council have decided to construct a Neighbourhood Plan covering Tenbury and Burford. This is a long term venture to influence what we want for the neighbourhood to augment the local plans on both sides of the river.

## **St Michaels College**

Empty since 2020 with a landmark, listed, neo-gothic principal building, faced with mounting maintenance costs and a difficult economic climate for boarding schools, the owner has put together a team to develop a new use for the site under new ownership. MHDC, local councillors and groups are being consulted to maximise input on the way forward. Obviously, this site has the potential to re-emerge as an asset to our area.

## **The Oak, Tenbury**

Empty and on the market for some years, falling into disrepair and a site for fly-tipping. I perceive a difficulty in finding a buyer of a small housing development site treated as a whole with the listed building. I have written to MHDC Planning asking for the listed site to be split to allow the two distinct areas each to find a buyer so that the individual parts can be re-purposed to the advantage of the Town.
