Minutes of the annual meeting held on 19th May 2022 at 7.30pm

- **3.** Election of Vice Chairman: It was proposed by D. Milward, seconded by S. Everitt that H. Rigby be elected Vice Chairman. All agreed.
- **4. Annual report of the Parish:** An annual report was made by the outgoing Chairman A. Jones.
- 5. **Minutes of the annual meeting held 22nd January 2022:** The Minutes were agreed and signed as a true record. Proposed S. Everitt, seconded A. Jones. All agreed. No matters arising.
- 6. Financial Matters: The meeting noted that finances were satisfactory. The annual accounts were approved as circulated. The Annual Governance Statement and Annual Governance Statement were approved as circulated and the Certificate of Exemption was duly signed. The meeting held a review of the Clerk's salary, and it was agreed to increase it from £250.00 to £300.00 p.a. proposed D. Milward, seconded S. Everitt, all agreed. Payments were agreed as £200.00 for the Jubilee party and £150.00 for the Clerk. It was noted that the bank mandate needs to be changed to include the new Chairman.

- **9. Highways Matters:** The road from the village to High Lane has badly deteriorated and has water damage with lots of potholes to be reported. The drain on Harpley Lane junction has finally been repaired! The agricultural signage is being progressed by Hfds Council (Balfour Beatty) in conjunction with North Bromyard Group PC.
