ANNUAL MEETING OF ABBERLEY PARISH COUNCIL

Minutes of the Meeting held on Tuesday 21st May 2013 in the Village Hall at 9.15pm

- 1. The meeting was opened by the 2012-2013 Chairman, Cllr. T Nott.
- **2. Apologies**: These were received and accepted from Cllrs: Mr J Lakeman, Mrs C Knight and Mrs D Gage, in addition County Cllr. Dr K Pollock, District Cllr. P Cumming and Mr W Bennett.

3. Elections:

- **3.1** Chairman Cllr. Nott was proposed by Cllr. Crabbe and seconded by Cllr. Walker. The proposal was carried unanimously. Cllr. Nott accepted the Office of Chair and thanked his fellow Councillors; He then signed the Declaration of Office. Cllr. Goodman, on behalf of all the Councillors, thanked the Chairman for his hard work and his continuation in this role.
- **3.2** Vice-Chairman Cllr. Crabbe was proposed by the Chairman and seconded by Cllr. Goodman. The proposal was carried unanimously.
