The meeting was adjourned for Public Question Time

Residents made strong representations against Planning Application No. 11/0581/FULL – Plot 4, Woodrow Lane, Bluntington. This plot had not been developed when the other three properties had been built, but the original application No. WF/1096/00 had indicated that all the four properties on the site should be similar in design and construction. This new application was for a contemporary styled building with a large expanse of glass, which they did not consider was in keeping with their existing properties. In addition garage area had been repositioned from the original plans, which would obstruct views from neighbouring properties. They considered that the front of the building had considerable impact on the present traditional street scene.

Although not present, a letter had been received from a resident of The Green, regarding the proposed demolition of garages on the Green and building of four affordable houses. The garages were not considered to be redundant as some were still in use and would deprive tenants of their garages.

- 7.1 11/0558/FULL Erection of steel frame general purpose farm building to store fodder, etc at Longmore Farm, Longmore **No objections.**
- 7.2 11/0567/FULL Demolition of existing garages and construction of four affordable dwellings at land adjacent to The Green, Chaddesley Corbett **No objections.**
- 7.3 11/0581/FULL Proposed new dwelling on vacant plot, previously approved at Plot 4, Woodrow Lane, Bluntington. The original development of four properties on this site was covered by Planning Application No. WF/1096/00, which specified that all the properties should be of a similar style. This remaining plot was not developed at the same time as the other properties and the Parish Council considered that the proposed building was not consistent with other properties on the site, in particular its contemporary design and glass walls. The Parish Council recommended refusal of this application.
