The Minutes of Bredon Parish Council Meeting held at Bredon Village Hall on Monday 13th September 2010 at 7.15pm.

Mrs C Madden informed the council of the 'Bredons Got Talent' event taking place in November to raise funds for the BCPR. The organisers are hoping that this will become a yearly event to raise money for various organisations in the future. The council where asked;

The lease for the land at the bottom of the playing field had been renewed which will not allow any development on this land. Cllr Handy proposed, Cllr Rhodes seconded and it was agreed for the chairman to attend the next meeting of the group and to inform them of the renewal of the lease and the councils concerns about future maintenance and insurance.
