d) Neighbourhood Plan.

The Regulation 16 period has had to restart and will now be completed on 15th August. The Inspector's Interim Report on the Gloucester Cheltenham Tewkesbury Joint Core Strategy has identified the potential for strategic development at Mitton Bank which could deliver 1,100 dwellings, and has stated that its exclusion from the Gloucestershire housing market area should not be an obstacle to its delivery. She recommends that the JCS authorities engage in discussions with Wychavon with a view to seeking their agreement on the release of land at Mitton to contribute towards Tewkesbury's housing requirement. If Wychavon agrees to allocate part or all of these sites, this should be set out in a Memorandum of Agreement and included in the JCS. Cllrs A Darby, M Darby and A Hardman will be attending the hearing to be held 6th and 7th July 2016. This could have implications for the Neighbourhood Plan, which could potentially be found to be in conflict with the emerging JCS. The council agreed for Cllrs Hardman and M Darby to speak on behalf of Bredon Parish Council and represent its interests.
