STOULTON PARISH COUNCIL

Minutes of Stoulton Parish Council held at Stoulton Village Hall on Monday 7th September 2009 at 7.00pm.

Speeding through Stoulton is an issue for many residents; Mr Digger explained that resources are channelled to areas where casualties have occurred. South Worcestershire is below the national average so this proves their focus to be correct. As the traffic unit is based in Pershore the road through Stoulton is used by police patrols extensively. Stoulton is deemed to be a local issue and 'ad hoc' enforcement does take place, covert or overt enforcement seems to have the same effect. The 30 mile per hour stretch in Stoulton, because it is within the 2/10th of a mile limit and has bends either side, is not an easy place to enforce. The whole of the County is having its speed audited and some roads will be reviewed, the parish council will be included in the consultation process. Apart from speed enforcement there are other ways to reduce speed; vehicle activates flashing signs, slow down signs, buffer zones and the narrowing of the carriageway with white lines.

Mr Fullee reiterated the views of Mr Digger and informed the council that he has access to portable signs that could be used; they only prove to be successful if they are moved around.

It was agreed by both Mr Digger and Mr Fullee that data would be collected and analysed hopefully in time for the next meeting. If there is a need for action it will be discussed at a later date.

Mr Barnham explained the history of the bus stop and offered to reinstate the stop to its former position.

- W/09/01833/CU Former Railway Goods Yard, Egdon Lane, Egdon Use of former railway goods yard as vehicle and machinery storage compound and for storage of inert materials. The council recommends the application is rejected for the following reasons
 - a) The location at the foot of the railway bridge would be totally unsuitable for the turning in and exit of HGV's.
 - b) A public footpath crosses the site at the level crossing.
 - c) The area near the entrance to the site does suffer from flooding during heavy rain and increased heavy traffic in that area could affect the road surface even more
 - d) The council has concerns for health and safety of the domestic residences in close proximity to the site.
 - e) Waste processing / recycling on the grounds of noise and dust pollution.
 - f) Dust from asbestos waste generated by the site
 - g) The photos show lots of black bin bags and goodness knows what's in them. Applicant should be asked to detail the type of "inert waste" so that the materials can be mentioned in the application and monitored thereafter.
