- Abbotswood Railway Bridge will be opened shortly under traffic lights, once work has been carried out elsewhere on the line, the bridge will be closed again for permanent repairs to be carried out.
- Cllr Adams had been contacted by Highways regarding the placing of Roundels on the road through Stoulton, the council agreed to part fund this work, Cllr Adams will fund the rest out of his budget.
- A new Highways Liaison officer will be in office shortly.

- The parishes effected by the Wind Turbine will received a joint income of £2,500.00 per annum which will be placed with 'Welcome to the Future' to administer. Parishes will be able to bid for funding.
- The changes in parliamentary boundaries taking place will read place Stoulton in the Worcester Constituency, but still in Wychavon District Council.

f) Speeding.

Cllrs Howard and Woodcock had meet with Cllr Rob Adams, Martin Rowe (Transport Strategy Manager of WCC) and representatives from Norton and Whittington Parish Councils regarding Parkway Station and traffic management.

The councillors made Mr Rowe aware of the speeding and traffic issues in the three parishes.

Mr Rowe outlined a possible scheme which included the closure of Woodbury Lane to vehicles, using Woodbury Lane, although the majority of the meeting felt this would be a good idea and would decrease traffic through Norton but perhaps lead to an increase through Stoulton. Norton Cllrs were opposed.

The main objective of the meeting was to make Mr Rowe aware of the issues in the parish which was achieved by Mr Rowe stating that all three parishes would be consulted at an early stage by consultant's appointed to design the scheme.
