1. Apologies for Absence.

Apologies were received and accepted from PC Greenhouse.

2. Declaration of Interests.

Councillors were reminded to update their register of interests. Cllr Perry declared a prejudicial interest in item 9a iii and left the room whilst the item was discussed and took no part in the decision.

3. To Consider the Adoption of the Minutes Of the Meeting Held On 26th January 2012.

a) To Consider Invoices for Payment.

Re-mark white road markings at 30mph terminal point (current marking incomplete/worn)

Pennylands Bank

Provide 30 mph roundels at terminal point.

General

Provide pairs of 30mph repeater roundel road markings at key points along the route.

Clerk to report further potholes in Blacksmiths Lane.

The council agreed for Wychavon to carry out a 'Safety Check' on the Play area.
