

# CHILDSWICKHAM PARISH COUNCIL

The minutes of Childswickham Parish Council Meeting held at The Memorial Hall, Childswickham on Thursday 25<sup>th</sup> September 2014.

*Mr Childs asked the following questions.*

1. *What was happening with the SWDP.*

2. *Why was the comment on application no W/14/01672/OU - Bungalow Farm, Murcot Road, late?*

Cllr Patrick had already explained to another parishioner that, the comment had been entered on the WDC website on the 29<sup>th</sup> August, a receipt was obtained. According to WDC planning officer, there had been a problem with the website that morning, however the comment would be taken into account and submitted on to the site.

3. *Why had the clerk not sent notification of the planning application at W/14/01974/PP - 3 Wyckham Court, Buckland Road.*

The clerk had been on holiday, and had not realised that all applications were required and not just applications for developments.

The council reiterated that the parish council is only a consultee in the planning process, and that the onus is on parishioners to look at local planning applications, all application are on the WDC web site and weekly list is available at <http://www.wychavon.gov.uk/planning-weekly-list>
