5/11/14 Community access defibrillator scheme.

Representatives from West Midlands Ambulance Service, gave a presentation on the various types of defibrillator systems which were available for the Council to purchase. Examples of defibrillator housing cabinets were also circulated. Grant aid for purchase of the equipment and training in its use could be provided by the British Heart Foundation and West Midlands Ambulance Service. Members agreed that consideration should be given to purchasing a defibrillator which could be sited at a suitable location within the Parish.

E mail from Mr Gary Robinson regarding various issues within the Parish.

(a) Request for protective fencing around the Preaching Cross in Church Street to prevent damage by passing traffic. The Council did not feel that this would be helpful as it would further narrow the existing junction there. Research into the possibility of securing grant aid for the

cleaning of the Village Hall War Memorial would be undertaken. English heritage (EH) had been contacted to see if grant funding could be made available for cleaning of the Cross. Currently EH were happy that the preaching cross was in a relatively good condition but a watching brief would continue to be made.

(b) **Ongoing issue with the state of roads and pavements throughout the parish** This had been reported to the County council for their attention but their maintenance budgets were severely constricted and such works were being undertaken on a priority ranking basis throughout the County

7/11/14 County Councillors Report

The planning application <u>14/02399</u> for a mixed residential development of 40 dwellings on land at Wyre Hill would be called in by the District Council planning to committee for consideration if officers were to recommend it for approval.

Further repairs to the Eastern Bridge barrier system would be undertaken by the county council although it was reaching the stage where the county council might not be willing to continue to fund the ongoing costs of the damage which was being caused by errant vehicle drivers. The police had been asked to put more effort into investigating the deliberate damage of the barriers. This had also been raised with the police at a recent PACT meeting.

Tom Comerford is the new highways liaison officer appointed for the area and Cllr Tucker requested that she be sent a list of outstanding of maintenance issues in the Parish so that she could follow up on progress with them.

The Poplar Avenue estate had now finally been given adopted status by the County Council

(b) 2014/15 Draft budget

The Clerk presented a paper setting out the indicative net expenditure budget and anticipated precept for 2015/16. The Council resolved that the precept for 2015/16 should be limited to an increase of no more than 1.98% over 2014/15 figure.

Following discussion it was agreed that the 2015/16 Parish Precept should be set at a sum of £ 11,380. The relevant precept request form would be sent to the District Council

12/11/14 Assets of Community value

The right gives eligible groups the opportunity to identify and nominate assets that are of value to the local community and gives them a fair chance to make a bid to buy them on the open market if the owner decides to sell.

A community can use this right to buy a local asset like a village shop, community centre, library, children's centre, allotment or pub. The right covers private as well as public assets.

It was agreed to request the District Council to establish the Anchor Inn on their list of assets which are deemed to be valuable to the local community.

If the request was granted then this would effectively give the Parish Council or a community group a six month time frame on being notified of the sale of the property to formulate a bid to purchase it.
