16/173 To consider installation and/or maintenance of planters in the village AND To consider replacing the seat in Main Street.

The Chairman requested that item 13 be considered alongside this item.

Quotations had been received for both planters and seat, it was agreed to purchase both the planters and seat from Amberol because the company had offered a reduced delivery charge to achieve the best price. It was agreed that 4 planters should be purchased together with a low maintenance seat at a cost of £1141 + vat. Proposed AW Seconded JM.

It was agreed that the PC could not justify the cost of future maintenance for the BT phone box in Newtown because no alternative use could be found due to the location. It was noted that over the last 12 months BT advised that this phone box had not been used.

16/177 To consider the cost of treating the bus shelters in Laurels Road and near the Maypole.

Three quotations had been received, it was agreed to accept the quotation from MH Sandalls for £382. Proposed RE Seconded FY.

16/178 To consider request from RBL Club for donation towards urgent repairs.

Various discussions took place, it was agreed to support this application by awarding a donation for £1000 towards the cost of replacing the door to the rear of the club which was regularly used by Offenham Rovers Football Club for changing facilities. Proposed RE, Seconded AW

16/179 To consider any action required in relation to WCC land disposal information at Boat Lane, Offenham.

Various discussions took place and it was suggested that a Community Right to Bid would be appropriate for this parcel of land. WCC advised that Clerk that they did not wish to sell the land or to rent to the PC when enquiries were made for the purpose of allotments. The Clerk was requested to pursue a Community Right to Bid.

16/180 To consider plans and quotations supplied for potential works in the play area.

Plans had now been received from Wicksteed and Playdale which were examined, it was noted that seating and bins were included in one quotation which had not been requested. Playdale wished to make a presentation to the PC but it was suggested that the changes should be made before this could be considered. Wicksteed had agreed to break down the quotation so that works could take place in stages. The Clerk was requested to contact Heather Peachey in relation to applying for s106 money.
