Invoices and payments approved for settlement including account balances and payments. Proposed by Cllr Grant. Seconded by Cllr Johnson. All in favour.

- b. **Budget for 2019/20** Clerk provided a detailed breakdown of all sections of income and expenditure for consideration. It was agreed that budgets should be set for all tangible sections and an increase be included for 'repairs & maintenance' and administration' as they are not fixed amounts. Cllr Wright proposed that precept should prepare the PC for the purchase of land should it become available as well as other projects and this should be reflected in the precept request in January 2019. All in favour.
- c. Amendment to end of year accounts as at 31st March 2018- Clerk advised of an amendment to end of year accounts as a result of change from income and expenditure to receipts and payments. Despite the external auditor advising that the accounts should be changed, this is incorrect. Internal auditor has re-assessed the accounts and they have been adjusted to reflect the change in accounting procedure. The clerk will now resubmit the figures to external auditor for consideration. The signing of the accounts by the Chairman was witnessed.

ITEMS FOR DISCUSSION.

- 1. NHB- Proposal from Bretforton Silver Band has been submitted and acknowledged.
- 2. TPO list- This has been chased with Sally Griffiths, no response has been received to date.
- 3. Smartwater- No response has been received from residents, it was agreed not to proceed.
- 4. BG- Councillors were unable to agree on the appropriate wording of the rules. Cllr Wright proposed to keep rules unchanged, seconded by Cllr Cleveland however agreement could not be reached. Councillors have until December meeting to decide on wording or the rules will be remain unchanged.
- 5. Blue brick footpath repairs- Highways have confirmed that work can be carried out on blue bricks and bricks changed where necessary. Cllr Davis will obtain stock level and

- delivery costs and purchase bricks up to £1000. Proposed by Cllr Cleveland, seconded by Cllr Wright with a unanimous vote in favour.
- 6. Bretforton Sports Club- The provision of a bin at Bretforton Sports Club was considered. It was agreed to purchase a bin and arrange for it to be emptied. Proposed by Cllr Cleveland, seconded by Cllr Johnson with a unanimous vote in favour.
- 7. 'Grass Cutting Tender' documents were considered by Councillors and agreed for season commencing March 2019 for a 3 year period. A site visit can be arranged if required. This does not include play areas or burial ground. It was agreed to send to all local grass contractors, advertise on noticeboards and webpage and magazine in the first instance.
- 8. 'Burial Ground Maintenance Tender' details for season commencing March 2019- It was agreed to advertise this to local gardeners in the first instance via webpage, magazine and noticeboards, it was agreed that a £50 fee be offered per visit.
- 9. Dog poo on Ivy lane- A number of complaints have been received regarding dog poo in Ivy Lane. There is a bin already in place. Put piece in magazine reminding residents of fine and asking them to report an incident.
- 10. Village store- Cllr Grant will hold inventory and keys for store and will organise racking etc. Cllr Wright will supply a lock at cost.

Wychavon District Council.

- Diamond Jubilee Community Recognition Award 2018/19- It was agreed to not make a nomination for this year.
- Bus service provision- Cllrs do not have enough knowledge of bus service to respond to survey.
- Village Culture Submission-15th November 2018- It was agreed that the PC application should be withdrawn as cllrs feel that they do not have a project that would benefit all residents within the village. It was agreed to support village activities on an individual basis.
