3. Minutes:

4. Clerk – Progress Report on actions from minutes 16th May 2011

a. Insurance damage claims The Green

b. Highways, Hedges, Potholes

Cllrs M Armitage and D Luscombe gave an update on their initial considerations. Agreed they would present a fuller report to the November 2011 meeting.

k. Hindlip Lane

Chairman confirmed Worcs CC Highways team will be reviewing signage to eastern end of Hindlip Lane.

m. Copcut Elm - Copcut Lane Parking

The Chairman met with the owners of the Copcut Elm not aware of the car parking problems on Copcut Lane or around the Bus Stop area on the A38 frontage.

Existing car parking capacity at the pub is 45 and the owners have not been able to expand its parking capacity. The Owners agreed to monitor car parking on Copcut Lane, especially when events occur.

5. Chairman

a. Update on South Worcestershire Development Plan and publication of SHLAA

Details on Wychavon Council's Extra Ordinary meeting on 5th July 2011 was reported on discussions leading to approval of the 2011-2030 Draft South Worcs Development Plan Preferred Options for public consultation from September to November 2011. One event has been requested to be held at Salwarpe Village Hall.

The Authority urgently needs to have a Definitive Plan in place to maintain control of development to prevent Developer led submissions of numerous planning applications during the gap between the abolishing of the SW Joint Core Strategy and the new joint South Worcestershire Dev. Plan.

b. Report on the proposed Yew Tree Hill Development - W/11/01073/OU

Attention was drawn to an amendment on the submitted response for the Yew Tree Application W/11/01073, regarding creating a major road diversion into the proposed site within Droitwich Towns boundary but cutting off the historic Pulley Lane within Salwarpe Parish to form a 'T' junction thereby

c. Review Standing Orders (circulated by email with agenda)

Standing Orders were reviewed relating to Planning Consultations to consider the forming of a Planning Committee. It was agreed not to form a Committee and continue with the existing Document Circulation System along with the existing laid down Standing Orders.

To be reviewed annually to keep up-to-date with proposed future changes to the Planning system by the introduction of Electronic Online methods with CD application documentation.

d. New initiative by Wychavon DC supporting Community purchase of heating oil

Attention was drawn to a fuel poverty initiative by Wychavon for rural areas and Events planned to establish whether there is an interest in organising collective purchasing power for communities dependent solely on LPG Gas and Oil. Cllr P Oakley agreed to attend one event and report back on the details.

6. Notice of review of Polling district and places

Wychavon District Council are undertaking a review of polling districts and polling places and Parish Councils are invited to make comments on any changes they wish to be considered.

Cllrs requested further information on the maximum distances that the electorate are expected to walk (or travel) to vote at a polling station, and the percentage of voters who turned out to vote at the last elections and how many/percentage of people who used a postal vote.

Clerk to circulate information for response to be collated by deadline of 5th August 2011.

7. Reports of County & District Councillors

C.Cllr Miller reported that the County's Discretionary Grant for 2011-2012 across all parish councils will be £10,000 for use on schemes such as Lengthsman. It was questioned whether our need for purchasing of essential Power Point equipment could be considered under this scheme. Enquiries will be made.

C.Cllr Miller outlined new initiatives under consideration or about to be rolled out by Wychavon District Council, including car parking schemes that benefit local residents and rates payback schemes for new homes that may benefit local parishes.
