- b. EVOLIS Radar Speed Sign (3342b) The Parish Council are now waiting for two more posts when these have been installed, we will order the second VAS. Chairman Mr M Hadley had circulated the latest results for Bradley Green and asked for the VAS to be turned around.
- c. The Rural Broadband Voucher Scheme (3342c) A meeting was held in the VH on 3rd February 2020 for Airband to give an update of the progress of their Fibre-to-the-Door proposal, they have also decided to include Bradley Green in their offer.
- d. Land at the junction of Flying Horse Lane and the B4090 (3342d) Mark Lane, Monitoring & Enforcement Officer, WCC, will be in contact when he has more information.
- e. Overgrown hedges in Middle Lane and Earls Common Road (3336) Earls common Road has been cut and the clerk has contacted the other owner who have agreed to attend to this.
