3407 PROGRESS REPORTS

- a. Police update (3394a) PCSO Aiden Goundry stated there was nothing to report. PC Joe Brooks reported that they had performed some impromptu speed checks in the village and that all the drivers were well behaved, no one was reported.
- b. EVOLIS Radar Speed Sign (3394b) The two posts for S&B had been delivered and the one in Stock Green had been erected it was agreed that the second VAS should be ordered, Chair Mr M Hadley proposed and seconded by Cllr Mr M Bates.
- c. Land at the junction of Flying Horse Lane and the B4090 (3394d) Mark Lane, Monitoring & Enforcement Officer, WCC, the Clerk has asked Mark that in view of the time already taken could he find a way to speed up the process. Mark replied that "It is difficult at the current time to move this forward when communication is not forthcoming from the owner of the land, despite several attempts to make contact, and the restrictions in place regarding making site inspections extremely difficult or nigh on impossible" the Clerk will keep monitoring the situation.
- d. Right of way signs at Priest Bridge (3394f) Barry Barns from WCC Highways, the Clerk has asked Mr Barns to arrange an "onsite meeting" with Kieran Hemstock from the Traffic Management Team to discuss this and agree a way forward to settle this matter.
- e. Roundhill solar farm and battery storage facility, Worcestershire, on behalf of JBM Solar Projects (UK) Ltd. (3394h) the Clerk had contacted Inkberrow PC who had nothing more to report.

To discuss the drainage issues raised by Mr Pawel Pietrasiak owner of the "old Bird-in-Hand" (3394k) - this is an ongoing situation with Barry Barns from WCC Highways, the Clerk met with Mr Barnes to discuss this, he is trying to resolve this and has asked WCC Chairman (Mr P Tomlinson) for assistance, The PC are monitoring the situation.
- i. Old Red Lion current status (3394L) there is no more news as reported by District Councillor Mrs A steel above in 3405
- j. Lulworth Cottage, Church Road is an eyesore (3397) Lulworth Cottage is in FPC (Redditch) the Clerk had contacted Cllr Mr Brendon Clayton from Redditch BC, who replied that the matter is now in the hands of the officers of RBC and will provide an update when one is forthcoming.
