District Councillors Mrs A Steel reported that:

WDC has been able to maintain vital activities such as refuse collection, but a large part of its resources has inevitably been concentrated on the response to the pandemic, with various support measures available to individuals and to businesses.

Many Council staff have been working from home, however, from 21st June, Council staff were permitted no more than 60% of their time working from home, and site visits for planning and enforcement purposes have largely been suspended except for urgent cases.

- a. Police update (3465a) PCSO Aiden Goundry stated that there was nothing to report
- b. Roundhill solar farm and battery storage facility, Worcestershire, on behalf of JBM Solar Projects (UK) Ltd. (3465b) the Clerk had contacted Inkberrow PC (as this land is within their parish) who stated that they have not heard anything and have taken it off their agenda. Cllr Mr M Hadley reported that he had contacted JBM and they confirmed that the application was still active.
- c. Issues re: Ongoing disturbance at Upper Priest Bridge Farm, Dark Lane, Bradley Green B96 6SN (3465d) As this is in FPC the Clerk asked the Feckenham Clerk and RBC Cllr Mr C Warhurst for an update, in reply he stated that he is unable to comment at the moment, he knows that these things can take a long time to resolve as there is a live planning application at this time. The Clerk, Cllrs Mr M Hadley & Mr P Langham walked through the site in question (as there is a footpath) and noted that there is very large plant and machinery in operation together with several Caravans and people in operation, this was reported to Dale Birch, Development

Management Manager, Bromsgrove District Council and Redditch Borough Council who stated that this matter is now the responsibility of Worcestershire County Council, the Case Officer dealing with this matter is Mark Lane, Planning Monitoring and Enforcement Officer, this also includes any enforcement requirements.

Cllr Mr M Hadley stated that before we take this any further, we need hard facts.
