2099 Questions or Statements from Members of the Public:

This was followed by an informal discussion and questions with Mr Paul Middlebrough, Deputy Police & Crime Commissioner & Assistant PCCs, Office of the Police & Crime Commissioner, West Mercia.

Various issues were raised and addressed by Mr Middlebrough including Safer Neighbourhood Watch (neighbourhoodmatters.app) to report problems, "Snappit" to report dashcam footage, the Community Speed Watch request had been disappointing as the average vehicle speed through the village was too high to employ this, however, regular motor cycle speed enforcement was being introduced and would be positioned at various sites around the village. There were over 2500 police officers in West Mercia and 0300 123 2040 was available for reporting any issues.
