- 3251 MINUTES OF THE ANNUAL PARISH COUNCIL MEETING held on 9<sup>th</sup> January 2019 had been circulated. Cllr Mr M Bates proposed and seconded by Cllr Mrs P Warren and it was AGREED that the minutes of the Parish Council meeting be signed by the Chairman as a correct record.

#### 3252 PROGRESS REPORTS

- a. Police update (3239a) PCSO Aiden Goundry had sent in a report of a theft of number plates from a motor vehicle between 24/02/2019 and 03/03/2019 at Stockwood Lane.
- b. Invitation to discuss the latest plans for the Ex Red Lion Pub (3233c) Kim Barton, Community Led Housing Enabler, Housing and Planning Services, Wychavon District Council After many weeks of exploring various avenues Kim Barton & Nick Rands made a presentation about how they wished to move things along with a proposal for a Community Housing Scheme, they outlined this to the Parish Council and local residents who might want to be involved in this project. There was interest as indicated by the number of the public attending. Kim promised to keep the Councillors updated on the progress.
- c. EVOLIS Radar Speed Sign (3239b) –The VAS will be delivered w/b 18<sup>th</sup> March and the Lengthsman has erected the posts ready for installation, a vote of thanks was made to County Councillor Mr P Tomlinson for his generous contribution together with the contribution from the New Homes Bonus scheme.
- d. PC Notice Board at the Village Hall (3239d) the Clerk was asked to claim through our insurance company having had no success with tracing the driver, there is a £250 excess. The Clerk has ordered a new metal notice board, at £1,266 +VAT and Tom Manders will do the installation within the next week.
- e. Three drains in Church Road need repair (3239e) the one causing the problems has now been fixed.
- f. Gigabit Broadband Voucher Scheme (3239f) –this would be for residents of Stock Green whereby each resident can claim a voucher of £500 per a property and £2,500 for a property with a business from a Government scheme. The Clerk will co-ordinate the results of the questionnaire with BT Openreach and is now awaiting a quote for the installation.
- g. Visit to Severn Waste recovery site (3239g). The clerk had arranged for the councillors to visit the site on Friday 8<sup>th</sup> March, Michelle James SW Educations and Communications Officer introduced the site organisation and processes and gave a conducted tour.

County Councillor Mt P Tomlinson reported the Council Tax will be increased by 3 to 4% to cover the increasing costs of adult health care, also WCC had taken in and housed 50 Syrian refugees plus 17 from other areas.

District Councillor Mrs A Steel reported that WDC would not be increasing the Council Tax for the coming year, District Councillor Mrs A Steel added that the Community Legacy Fund was responsible for the New Homes Bonus and Section 106.

District Councillor Mr D Wilkinson reported that there was a push to remove the Broadband black holes in the area and that Robert Stepniewski, Senior Project Manager at WCC was responsible for this.
