- 7. **WINDPUMP:** The lights are still on at the windpump. English Heritage have recommended Christmas lights should stay on until end of January. Will continue with assembly when Councillors can meet up again.
- 8. **LENGTHSMAN SCHEME:** Siding out down Tutnall Lane, down from Hall and Tutnall Close. Remind Simon re orchards also Brockhill Lane. Cllr Whittaker stated that Lengthsman has done a good job at Agmore Lane.
- 9. HIGHWAY MATTERS: The Chairman was contacted by a Parishioner about Wharf Lane ditch smelling. Cllr Whittaker stated the Private Hospital had a history re discharge into brooks and ditches. Hospital has stated they have a licence to discharge into the ditch. Cllr Whittaker proposes involving Environmental Agency. Chairman proposed Worcester Regulatory Services, the Clerk will contact them. Ditch has been dug out by Animal Sanctuary and spoils are on the side, Cllr Denyer felt that it would end up back in the ditch in a few years. Animal Sanctuary could face a bill, Footpath Warden proposed the Lengthsman could do it but Cllr Whittaker stated ditch has already been dug out. County Cllr Taylor to mention to Richard Clewer and Public Health. Cllr Whittaker and Cllr Tolley to look at ditch at Brockhill Lane and Wharf Lane and report back. Cllr Tolley mentioned Council are working down Brockhill Lane with soil on one side and two lorries now can't pass and there is a mess now. County Cllr Taylor isn't sure it is a Council matter, it could be Waterways. He will ask Richard Clewer again. Cllr Ryan mentioned the chevrons by him were obscured, so he cleaned them.
