Cllr Middlebrough advised that the A38/A4104 roundabout was the subject of drone surveys and progress should be underway in the next 12/18 months. It would need to be understood that whilst under construction the area would suffer disruption. Cllr Middlebrough reported that the library strategy would go to cabinet on 29 January and proposed

to sustain the 21 existing libraries. The Police would be moving out of the current Upton location and the issues regarding back rent of the premises were under review. The ongoing matter of non payment of the levy to WCC by Taylor Wimpey in respect of the Pennywell development had now been escalated to the WCC legal department for collection. Clir Middlebrough advised that the Cemex Liaison meeting was scheduled for 28 January, subject to the application for the Rowing Lake being submitted.

The Chairman thanked the members of the public for attending. Public Questions:-

A Ryall resident suggested that in addition to the options for traffic calming on the Ryall Road a barrier could be considered for either entrance to Ryall road or The Beeches. Cllr Middlebrough advised this had been used effectively in Wyre Piddle where a £60 penalty fine was imposed.

Bow Lane Gravel Extraction Update - Cullimore & Cemex Plans As a result of the significant public interest Item 7 of the agenda was included within the Public Question time for the benefit of those residents present.

Cllr Jones introduced himself and provided an overview of the current two planning applications submitted by the Cullimore Group, one falling with Gloucestershire and one falling with Worcestershire. An explanation of the proposals of the applications and the various aspects to impact on the locality were reviewed. Cllr Jones advised that RPC had drafted a submission to both County Council Planning authorities for consideration and additional copies would be supplied to MHDC and Tewkesbury BC.

Cllr Middlebrough had arranged for a meeting at Gloucestershire CC which Cllr Jones attended and was provided with the opportunity to discuss various aspects of both applications with planning officers. The information obtained was incorporated into the RPC response submission. Residents were urged to make their own individual submissions and it was stressed that it was important for a local action group to monitor the situation on behalf of the residents. Whilst RPC would be happy to share information it was made clear that it could not form or administer any such action group.



The residents agreed to liaise amongst themselves and have since met in Ripple to discuss a co-ordinated form of action. It was pointed out that various aspects of the application documentation were inconsistent and significantly detrimental to the locality.

Cllr Jones also advised residents that various other local parcels of land had been included in the WCC call for sites which would significantly impact on the locality should further aggregate extraction be undertaken.
