- 4. Report from District Councillor - None received.
- 5. Report from County Councillor - Cllr Middleborough thanked Cllr Blake for his input to the recent visit by Hannah Davies to review highways issues within the parish. A regular meeting with WCC, combining neighbouring parishes shall be set up. Cllr Wilson agreed to represent RPC. The Lengthsman would be introduced to Hannah Davies in order to review the footpaths and communication regarding siding out of footpaths. The raising of the A4104 would shortly commence, Cllr Wilson requested that the bench on the Ryall side of Upton Bridge be retained throughout the work as it was an essential resting place for some residents walking to and from the town. Cllr Jones stressed the need for urgent attention to Stratford Lane. The 363 bus service timetable shall be subject to change commencing first week of October 2017. Cllr Middleborough suggested a survey of use to establish demand, clerk to liaise.

Cllr Middleborough left meeting at 19.45 to attend Kempsey council meeting.

Proposed new dwelling and garaging

Cllr Jones reported that the Inspectorate had approved the appeal at Strensham Road on a provisional 3 year basis to prove financial viability.

The gas tanks on the Pennywell development are to be increased from 4 to 6 but must be buried following a ruling by MHDC. The ground level on site must also be reduced back to original height. Concerns raised regarding potential flood risk to existing properties has not been addressed.

Gubber Hill Stables (Twyning) subject to a further hearing on 5 October at TBC. RPC will resubmit the original submission and prepare a further submission reiterating concerns regarding the contamination of the land and potential risks.

The proposal to incorporate velux windows in the tractor shed was recommended for refusal. Cllr Owenson to be made aware.

#### 8. Bank Account Signatory Review

The Chairman requested approval to add Cllr Aldridge as a signatory to the RPC bank account, this was unanimously agreed.

#### 9. Phone Boxes Adoption Update

The Chairman reported that the Naunton Phone contract had been signed and ownership would pass to Ripple Parish council. Cllr Blake would arrange a group to clean the kiosk. The listed Ripple phone box would remain the responsibility and property of BT. An application to MHDC for removal of listing would be required prior to decommissioning. The matter would be re-visited by RPC should this arise.

#### 10. Noticeboard Update

The order for four replacement noticeboards to be located at The Beeches, Naunton, Ryall Grove and Uckinghall had been placed. Delivery and installation date confirmation awaited. The existing community noticeboards would remain in situ.

#### 11. Speed Watch Update

Cllr Wilson reported that RPC had been accepted for the Speed Watch campaign. Cllr Wilson to recruit volunteers to undergo training. Currently awaiting application forms and date for training.

#### 12. BT/OpenReach Update

Clerk reported that the issues encountered in the Ripple area were now resolved, telephone and broadband services were functioning.

### 13. Annual Newsletter Arrangements

Clerk distributed list of proposed topics to be included in the newsletter and requested copy from contributors by the end of September. The format was agreed to be similar to the previous edition.

#### 14. Highways and Transport Review

Clerk to continue to report on WCC website. Councillors and residents to report on the website also. Traffic calming measures in the form of "white roadside gates" to be priced and considered for Ryall Road. Appropriate contacts to be supplied by WCC. Whilst WCC would assist with cost of installation, RPC would be responsible for cost of the street furniture. Clerk to investigate provision of wheelie bin stickers encouraging reduction of traffic speed.

### 15. Co-Opting of Additional Councillors

Chairman requested suggestions on how to attract new councillors. It was agreed that a request for applicants would appear in the newsletter. The clerk had placed an advertisement notice on the parish noticeboards. Details also to appear on the website and Facebook (Cllr Aldridge reported 37 followers now). Representation of residents of the Ripple and Uckinghall area would be helpful to provide a balanced representation of the parish.

#### **Public Question Time:**

A resident of Bow Lane Ripple expressed concerns with regard to dangerously out of control dogs in Bow Lane. Chairman and Councillors suggested discussion with MHDC and local police together with the RSPCA. The resident confirmed that he had been in discussion with both MHDCl and police. Despite undertakings from the owners the animals were still regularly unrestrained causing concern and anxiety. Most recently, there had been an incident involving a pig from the same premises/ownership. Cllr Owenson had attended the property where numerous incidents have occurred and undertook to review the situation, together with the matter of an ongoing breach of planning regulations relating to a mobile home. Cllr Middleborough offered the benefit of his experience of similar situation.
