

THE SHELSLEYS PARISH COUNCIL
Meeting held on 9th September at 7.00pm in the year 2014

Present: Mr A N Champion Chairman, J Stinton, W Sutherland, B Hart, T Taylor, Mrs H Webb, D Styles and D Bates.

In Attendance: Councillor Dr Pollock, 3 members of the public and the Clerk (Mrs J Speyer).

3.1 Apologies: C Roberts and District Councillor Farmer.

3.2 Declaration of Interest: D Styles for item 8

3.3 Councillor for Shelsley Beauchamp: Mr Dave Bates was welcomed.

3.4 Minutes: The minutes of July 8th 2014 were signed as a true record.

Public Question Time:

Q. Had a letter regarding the Village Hall and Social Club been circulated as per minutes of July 8th?

A. With the current situation between the Social Club and VHMC this was not deemed necessary at present.

Q. There is an apparent surge in the frequency of the Shelsley Walsh hill climb events. This has given rise to an increase in traffic and to some extent noise. The traffic increase and speed is of particular note especially at the event held weekend before last.

Q. Electrical supply disruption. A. Advised contacting supplier.

3.5 County Councillor's Report:

Dr Pollock gave his report. He gave some suggestions about the problems with traffic at the hill climb.

The Scrutiny Panel meets next week to discuss Broadband. He mentioned the lack of preventative maintenance by BT. From September 1st Bus Route changes with regard to Clifton and the numbers employed in Worcester Regulatory Services.

3.6 Safer Roads Partnership:

An email has been received advising that placing a van to carry out speed enforcement would be difficult due to the nature of the roads and may add to the problems but that the local policing team will pay special attention and also the Road Policing Unit will be contacted. They will be able to use marked and unmarked cars and motorcycles to give the area attention on the relevant days.

3.7 Highways, Footpaths and Lengthsman:

There was no Lengthsman's Report or worksheets.

Progress report at Leys, no progress, Clerk to investigate.

Collapsed drain in Pard House Lane ref 6259878, notification received of a road closure for repair of the drain.

The dislodged inspection cover at Kingswood junction has again been reported but no report received from WCC.

B4203 poor road surface reported. Advised by WCC that a routine inspection will take place to identify any problems with the road surface.

Batteries for VAS. The purchase of batteries, the cost to be shared between four parishes was agreed to the sum of £40.00.

The improvement to the hedges bordering the quarry was commented on. The PC is grateful for the extensive work carried out.

3.11 Finance and Audit:

External Auditor's report. Two matters arising. Council Tax Support Grant of £144 should be
included in Box 3. Box 2 should read 4856 and box 3 2391.

It appears that the internal auditor may have been involved in preparing the figures for the
annual return. The internal auditor should not be requested to undertake tasks that may
compromise his independence.

The Clerk explained that the internal auditor had overwritten some of the figures in red pen
so that it appeared he may have inserted them This was not the case.

One payment was approved. The VAT element on the last payment to the Lengthsman was
omitted. This amounted to £64.00

3.12 Village Hall Management Committee:

The Vice Chairman reported that he had attended a meeting with the Chairmen of the VHMC
and Social Club where a discussion had taken place about the possibility of the Social Club
taking on a longer term lease with similar payment arrangements and paying off the back
rent. It is understood a VHMC meeting is to take place next week, the content to be reported
at the next Parish Council meeting in November.
